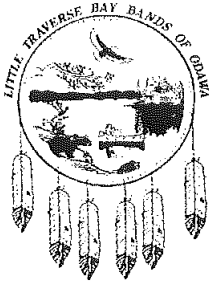

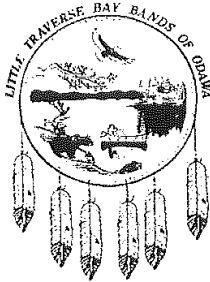

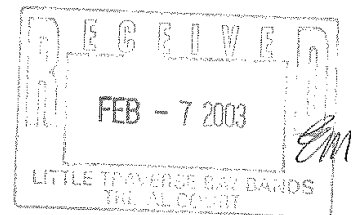
**WHEREFORE, IT IS ORDERED THAT:**

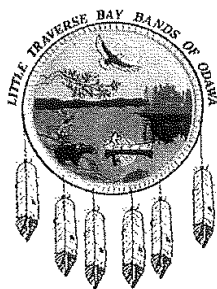
