

1. Mr. Beaver did not appear for the Show Cause Hearing on November 14, 2007.

THIS COURT FINDS:

1. This Court entered a default judgment against the Respondent on December 20, 2002.
2. The Respondent was granted an extension of time to pay the default judgment against him on January 29, 2003.
3. The Respondent was sent a letter from the Court Clerk on this matter March 3, 2003.
4. Respondent did not pay the outstanding fine and court costs in this matter by February 15, 2003 as ordered by this Court on January 29, 2003.
5. A *Show Cause Hearing* was held on August 15, 2003. Respondent failed to show or contact the Court.

WHEREFORE, IT IS ORDERED THAT:

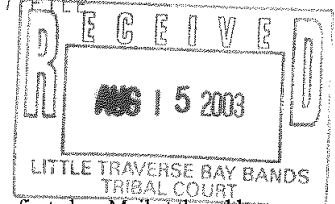

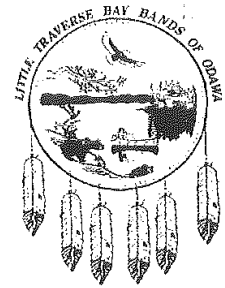

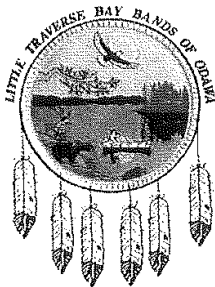

2. Return this notice with a certified check or money order in the amount of the judgment by January 14, 2003^{3:00pm} by 5:00pm.

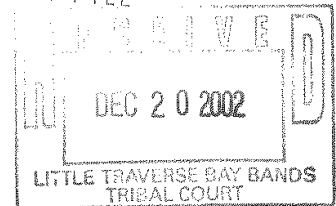
