**THE COURT FINDS:**

1. Mr. Masse did not appear for the Show Cause Hearing on November 14, 2007.
2. However, Mr. Masse did send to the Court \$100.00 that was received on November 15, 2007.
3. Mr. Masse was ordered by this Court to pay fines and court costs of \$300.00 in this matter by April 9, 2003.

**WHEREFORE, IT IS ORDERED THAT:**

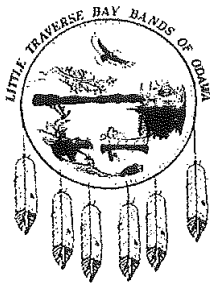

**WHEREFORE, IT IS ORDERED THAT:**

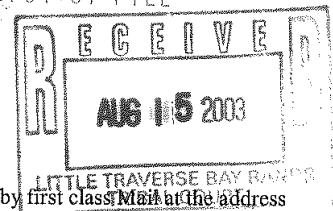
1. Defendant's LTBB Natural Resources privileges and licenses be revoked.

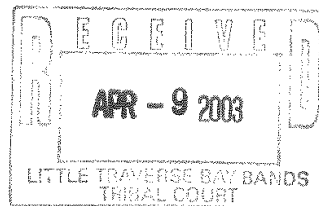
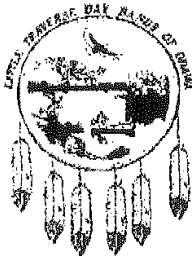
Defendant shall pay a \$50.00 fine and \$50 court costs on each of the three (3) charges. Thus the total owed is \$300.00.

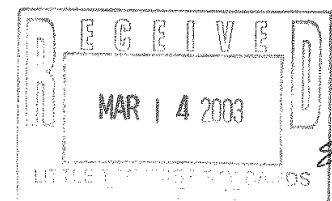
