THE COURT FINDS:

1. After the respondent failed to appear for three show cause hearings and failed to pay outstanding fines and court costs stemming from a citation issued in 2004, Honorable Michael Petoskey found him in contempt of court and ordered that the Department of Natural Resources not issue any treaty licenses to respondent until further order of this court.
2. This Court then scheduled a fourth show cause hearing on November 14, 2007. Mr. Adams again failed to appear for this hearing. After the respondent failed to appear at the November 14, 2007 hearing this Judge gave the respondent until December 20, 2007 to pay his outstanding fines and court costs indicating that if he failed to do so, a Bench warrant may be issued for his arrest.
3. Mr. Adams did not pay the fines and court costs as ordered; therefore a bench warrant was issued for his arrest on December 21, 2007. The Respondent was arrested on the bench warrant on February 21, 2008 and was brought to LTBB Law Enforcement prior to being transported to jail.
4. The Court Administrator met with Mr. Adams while he was being detained by LTBB Law Enforcement to determine if Mr. Adams could make arrangements to pay the fines and costs ordered by this Court prior to him being transported to jail. Mr. Adams made arrangements and the fines and costs were submitted to the Court.

WHEREFORE, IT IS ORDERED THAT:

1. The Court was concerned with Mr. Adams satisfying the past judgment against him, which he has now satisfied, therefore, the respondent will not be held in further contempt of court and he may be released from custody.
2. The Natural Resources Department may issue treaty licenses to the respondent under the requirements and/or regulations of their department.

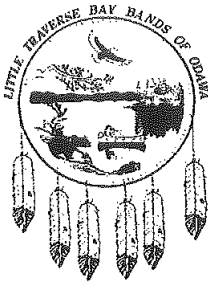

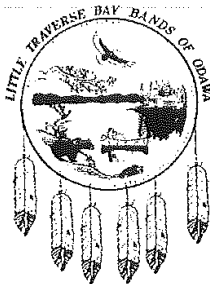

1. Mr. Adams did not appear for the Show Cause Hearing on November 14, 2007.
2. Mr. Adams has not paid the outstanding fines and court costs in this matter by October 30, 2004 as order by this Court.

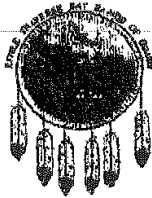

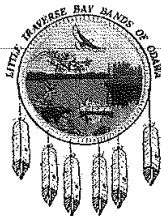

This Court conducted a Show Cause Hearing on September 30, 2004. The Respondent, John William Adams, failed to satisfy the *Default Judgment* against him on August 05, 2004. 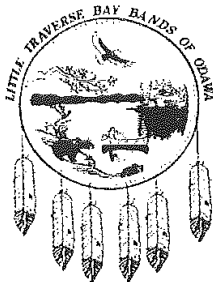
This Court finds Mr. John Adams in Contempt of Court for failure to pay the *Default Judgment* fine and court costs on time. The Court imposes a contempt fine of Twenty-Five dollars (\$25.00) and costs in the amount of Twenty-Five dollars (\$25.00).

Respondent has thirty (30) days to pay both judgments against him. The total amount due is One Hundred Fifty dollars (\$150.00).

WHEREFORE, IT IS SO ORDERED that Mr. John Adams pay the above-cited fines and court costs of \$150.00 (One Hundred Fifty dollars) on or by October 30, 2004.

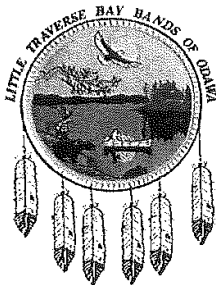

DEFAULT JUDGMENT

1. Default judgment is entered in the amount of \$ 100.00 (\$50.00 Fine and \$ 50.00 Court Costs) as stated on the Plea by Mail Form.
2. Return this notice with a certified check or money order in the amount of the judgment by September 06, 2004 by 5:00pm.

If you fail to pay, the Court will schedule a SHOW CAUSE HEARING for you to show cause why you should not be held in contempt of court for not paying the fine and court costs on time. If you are found to be in contempt of court, the court may REVOKE your LTBB Natural Resources privileges and you will be required to petition the Court for reinstatement of your LTBB Natural Resources privileges. Once privileges are revoked, they will not be reinstated until the fine and costs are paid in full AND you will be required to petition the Court for reinstatement of treaty privileges. You will also have to pay a filing fee of \$ 50.00 when you file the petition.
