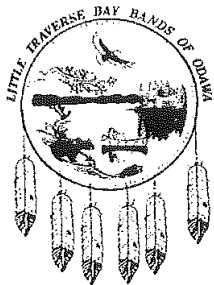

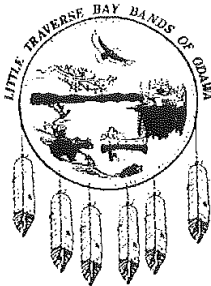
The Court imposes a fine of Twenty-Five Dollars (\$25.00) and costs in the amount of Twenty-Five Dollars (\$25.00).
