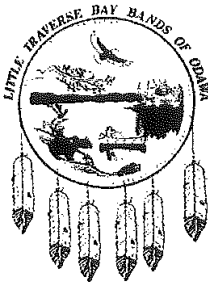

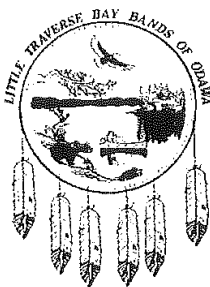
On October 17, 2006, the Respondent was cited for a violation of Section XVIII of the Natural Resource Regulations for the Little Traverse Bay Bands of Odawa Indians Reservation, 18.06 A for fishing without a tribal license. This Court conducted a hearing on November 15, 2006, before the Honorable Jenny Lee Kronk, Associate Judge, at which Mr. Serva pled responsible. The Court imposed a fine of One Hundred Dollars (\$100.00) and costs in the amount of Fifty Dollars (\$50.00). Respondent was ordered to pay the above-cited fines and court costs of One Hundred and Fifty Dollars (\$150.00) on or by December 15, 2006.

On December 15, 2006, Respondent appeared at Tribal Court and asked for an extension of the payment of the fine because his paycheck was not as much as he expected it to be.

Therefore, it is ORDERED that Martin Stephen Serva, Jr., shall pay \$150.00 on or before January 3, 2007.

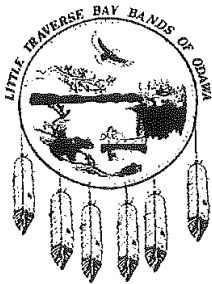
This Court conducted a Hearing on November 15, 2006 before Jenny Lee Kronk, Associate Judge, at which Mr. Serva pled responsible.
