

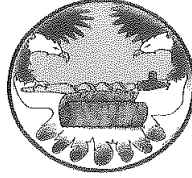

ORDER FOLLOWING HEARING

A hearing was held in this matter on June 10, 2009, the Honorable Jenny Lee Kronk, Little Traverse Bay Bands of Odawa Indians (LTBB) Associate Judge presiding. Present at the hearing were Roger Willis, LTBB Conservation Officer, Defendant Ryan R. Keshick, and Kevin Willis, LTBB Chief Conservation Officer.

Mr. Keshick pled responsible for Inland Fishing (spearing) Without a Valid and Current License, a violation of Section 12.01 of the LTBB 2009 Inland Consent Decree Rules and Regulations.

Therefore, it is ORDERED that Ryan R. Keshick shall pay a fine of \$100.00 by 5:00 p.m. on Friday, June 12, 2009. After the fine is paid, the LTBB Natural Resources Department may return the confiscated spear to Mr. Keshick.


