

DISCHARGE**


1. **THE COURT FINDS** that all conditions of probation were were not successfully completed.



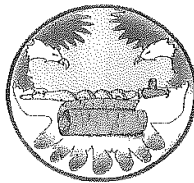

ORDER FOLLOWING SENTENCING HEARING

On September 6, 2011, the Little Traverse Bay Bands of Odawa Indians (LTBB) Natural Resources Department's (NRD) Conservation Officer, Michael P. McCreery, issued a Treaty Citation to the Defendant, David L. Minor, for a violation of the 2010 LTBB Inland Consent Decree Rules and Regulations, § XVIII (A) (4) for Harassing or Interfering with another legally licensed fishing person. Following a trial on October 11, 2011, at which time the Petitioner called four witnesses, the Court delivered its verdict and found the Defendant guilty of the offense.

At a Sentencing Hearing held in this matter on November 15, 2011, the Court sentenced the Defendant to forty (40) hours of Community Service, to be completed within three months with the LTBB's NRD. If the LTBB NRD does not have sufficient projects for the Defendant, the NRD shall notify the Court and the community service will be completed at the discretion of the Tribal Probation Officer.

Therefore, it is **ORDERED** that David L. Minor shall complete forty (40) hours of Community Service with the Little Traverse Bay Bands of Odawa Indians Natural Resources Department by February 15, 2012.
