Appearing at any location I am likely to be, including any school, my place of employment, or any other specified place by petitioner: _____

Approaching, confronting or following me in any public place or on private property.

Placing any objects on or delivering any objects to any property I own, lease, or occupy or my workplace

Interfering with me at my workplace or engaging in conduct that impairs my employment or educational environment or relationship.

Having access to information in records of any minor child of ours that could reveal my or any child's address, telephone number or other contact information.

Interfering with, damaging or destroying any property owned by me, including pets.

Purchasing or possessing a firearm.

Additional requested conditions for domestic PPOs:

Removing property from the joint residence, unless otherwise ordered by the Court.

Prohibit respondent from removing property from a joint resident, unless otherwise ordered by the Court.

6. **I request an ex parte order because immediate and irreparable injury, loss, or damage will occur between now and a hearing or because notice itself would precipitate adverse action before the order could be issued.**

Cause a Summons to be issued to respondent, setting a date, time, and place for a hearing to consider all relief to which petitioner may be entitled, including those matters contained in this Motion, and appropriate counseling for respondent and other relief as authorized by statute. Parties are entitled to at least 7-days notice for a hearing, pursuant to 9.1104B.
