DEPARTMENT OF COMMERCE FOR-PROFIT AND NON-PROFIT CORPORATION FEE SCHEDULE REG-WOS 2023-001 012623-002

I. Introduction. The purpose of these regulations is to establish the fee schedule for For-Profit and Non-Profit Corporation documents filed with the LTBB Department of Commerce.

II. Definitions:

A. **Military Veteran:** means a person who served in the active military, naval, or air service, and who was discharged or released therefrom under conditions other than dishonorable this includes United States Army, Navy, Marine Corps, Air Force, Coast Guard service, and members of the Reserves, Air or Army National Guard.

III. Fee Schedule:

- A. The following fees are hereby established:
 - 1. Filing an application for incorporation and proposed articles of incorporation: \$20.00
 - 2. For filing an application for an amendment to the articles of incorporation: \$5.00
 - 3. For filing a statement of change of name or address of registered agent: \$5.00
 - 4. For filing any other statement or report of a corporation:
 - a. Merger: \$20.00 for each entity involved in the merger
 - b. Dissolution: no cost
 - c. Annual Renewal: \$10.00
 - d. Other: \$10.00

- 5. For furnishing a certified copy of any document, instrument report or other paper relating to a corporation: \$10.00
- 6. For furnishing a certificate as to the status of a corporation or as to the existence or non-existence of facts relating to corporations:
 - a. Certificate of Good Standing or other status of Corporation: \$10.00
 - b. Certificate of Fact listing all documents filed: \$25.00
 - c. Certificate of Fact stating a particular fact or no fact on record: \$10.00
- 7. For uncertified copies, including copies sent electronically, to any person or group: \$5.00 per document requested
- 8. For furnishing a LTBB Odawa Tribal Business License in accordance with this Statute: \$10.00
- B. In accordance with Waganakising Odawak Statute 2021-009: Waiver of Fees for Military Veterans, all fees listed in this section are waived for Military Veterans.

IV. Payments

A. Payments can be made via cash, check, or money order made payable to the LTBB Department of Commerce.
