29. Protection of civilians in armed conflict

During the period under review, the Security Council held six meetings to consider the protection of civilians in armed conflict, and adopted two resolutions and two presidential statements, as detailed in table 1 below.

Amongst the main issues discussed by the Council during the period were the responsibilities and capacities of peacekeeping operations with mandates concerning the protection of civilians; measures that were needed to ensure the implementation of those mandates in the increasing complexity of field situations; and the challenges faced by women and girls in armed conflict settings. Building on resolution 1502 (2003) on the protection of United Nations and humanitarian personnel in conflict zones, the Council adopted resolution 2175 (2014) following its meeting marking World Humanitarian Day. At a high-level meeting on 27 May 2015, the Council adopted resolution 2222 (2015), its second decision dedicated exclusively to the protection of journalists in armed conflict.

Throughout 2014 and 2015, the Council continued including provisions relating to the protection of civilians in armed conflict in its country or region-specific decisions and in decisions relating to thematic issues.¹ As shown in table 2 below, the Council, *inter alia*, (i) condemned all forms of violence against civilians, particularly against women and girls; (ii) called upon all parties to a conflict to comply with their obligations under international

humanitarian law and human rights law and for all perpetrators of such crimes to be held accountable; (iii) demanded that all parties ensured full, safe and unhindered access for delivery of humanitarian assistance to populations in need, condemning attacks, threats, and acts of obstruction and violence perpetrated against humanitarian workers, including United Nations personnel; (iv) emphasised the primary responsibility of States to comply with their relevant obligations to protect civilians, including allowing the voluntary and safe return of refugees and internally displaced persons; (v) continued to include requests for additional monitoring mechanisms as well as reporting arrangements in order to improve the protection of civilians in armed conflict, and (vi) adopted targeted measures against perpetrators or expressed its strong intention to adopt such measures. In addition, the practice of strengthening mandates of United Nations peace operations with a view to protecting civilians continued to evolve.
