Authorization of the use of force	Provisions relating to general authorizations to "use all necessary means" in implementation of the mandate.
Protection of civilians including refugees and IDPs	Provisions relating to the protection of civilians under threat.
Protection of humanitarian / UN personnel and facilities / free movement of personnel and equipment	Provisions relating to the protection of humanitarian and/or UN personnel and facilities under threat or for references to ensuring the free movement.
Support to police	Provisions relating to operational support to national police, capacity-building, reform/restructuring, executive (international) policing
Support to military	Provisions relating to direct operational support to national military, including military training, operating joint patrols or other activities.
Security monitoring - patrolling – deterrence	Provisions relating to border security, security for specific areas or regions, including deterrence, security for a particular infrastructure or cultural heritage site, security of government officials and other state institutions
Maritime Security	Provisions relating to anti-piracy efforts.
Ceasefire monitoring	Provisions relating to monitoring of ceasefires.
Security Sector Reform	Provisions relating to security sector reform and instances where reform of the military is singled out.
Demilitarization and arms management	Provisions relating to Disarmament, Demobilization and Reintegration of combatants, monitoring of surrendered weapons, weapons removal and collection, demining, monitoring illicit weapons flows, and other arms control and counterproliferation activities.
Humanitarian support	Provisions relating to humanitarian support or coordination, including mandates related to refugees/IDPs and their return.
Human rights-related	Provisions relating to human rights, including specific reference to improving the human rights capabilities of governments, armed forces or others; monitoring, investigation; children and armed conflict; women and peace and security; youth and peace and security.

Rule of Law\Judicial matters	Provisions relating to support for the rule of law, legal and constitutional support and judicial and legal reform.
Political processes	Provisions relating to the facilitation of political dialogue, national reconciliation, good offices, conflict resolution, peace agreements, civil affairs, post-conflict peacebuilding.
Electoral assistance	Provisions relating to support for local or national elections, referendums and censuses.
Support to state institutions	Provisions relating to the establishment of administration, capacity-building of State institutions with the exception of the security sector and rule of law institutions.
International cooperation and coordination	Provisions relating to coordination and/or cooperation with donors, UN country teams, UN system agencies and entities, PKOs, SPMs, regional and subregional organizations.
Support to sanctions regimes	Provisions relating to support for the implementation of sanctions measures.
Public information	Provisions relating to providing information to the public, including references to radio stations or other kinds of information campaigns.
Civil-military coordination	Provisions relating to improving civilian-military coordination. This will generally apply to cases where there is a regional, multinational or other military force operating in parallel to a UN mission.
Mission impact assessment	Provisions relating to considering the environmental impacts of peacekeeping operations when fulfilling their mandated tasks.
