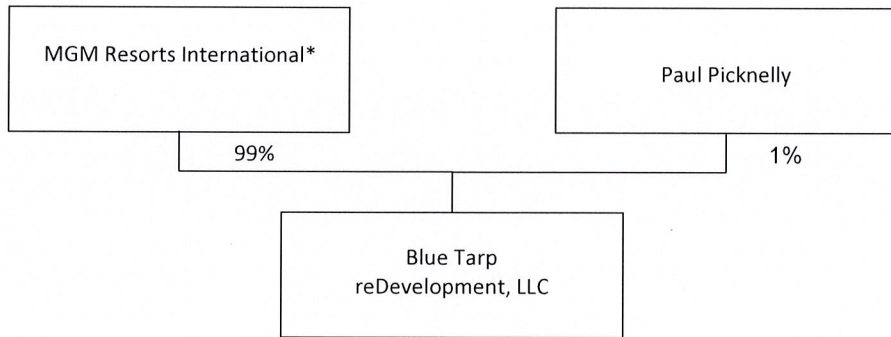

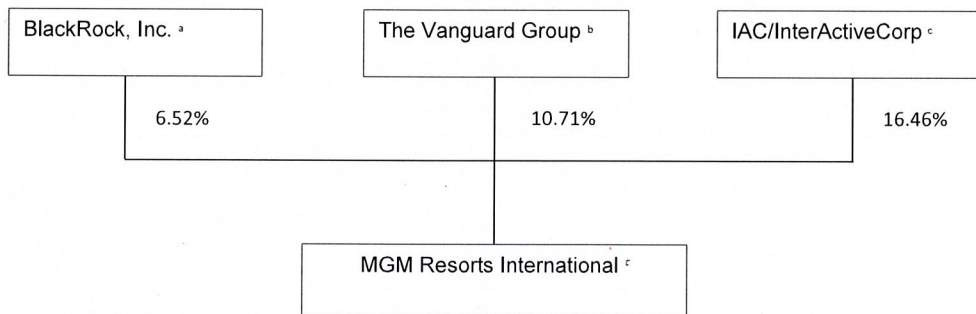

As reported in MGM’s Form 10-Q filed with the United States Securities and Exchange Commission (“SEC”) on August 3, 2022, there are 393,102,147 shares of MGM’s common stock issued and outstanding as of August 1, 2022.

^a According to a Schedule 13G filed with the SEC on February 1, 2022, and served on MGM by BlackRock, Inc. (“BlackRock”), Blackrock beneficially owned 25,615,689 shares (reflecting sole voting power of 22,431,853 shares and sole dispositive power of 25,615,689 shares), which represent 6.52% of MGM’s common stock as of August 26, 2022.

^b According to a Schedule 13G/A filed with the SEC on February 9, 2022, and served on MGM by The Vanguard Group (“Vanguard”), Vanguard beneficially owned 42,100,501 shares (reflecting sole voting power of 0 shares, sole dispositive power of 40,568,256 shares, shared voting power of 594,270 shares, and shared dispositive power of 1,532,245 shares), which represent 10.71% of MGM’s common stock as of August 26, 2022.

^c According to a Schedule 13D/A filed with the SEC on August 26, 2022, and served on MGM by IAC/InterActiveCorp (“IAC”), IAC beneficially owned 64,723,602 shares (reflecting sole voting power and sole dispositive power of 64,723,602 shares), which represent 16.46% of MGM’s common stock as of August 26, 2022.
