9	(2) "PAPER CARRYOUT BAG" DOES NOT INCLUDE:
10	(I) A PAPER BAG USED TO:
11	1. PACKAGE BULK ITEMS, INCLUDING FRUIT,
12	VEGETABLES, NUTS, GRAINS, CANDY, OR SMALL HARDWARE ITEMS;
13	2. CONTAIN UNWRAPPED PREPARED FOODS OR
14	BAKERY GOODS; OR
15	3. CONTAIN PRESCRIPTION DRUGS PROVIDED BY A
16	PHARMACIST.
17	(II) A PAPER BAG PROVIDED BY A FOOD SERVICE FACILITY
18	THAT IS NECESSARY TO MEET FOOD SAFETY AND CONTAMINATION
19	STANDARDS.

21	SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
22	the affirmative vote of five members of the County Council, shall take effect 14 days from the
23	date of enactment.
