The 2023-2024 Current Expense Budget Gifts and Grants Special Revenue Fund Assistance to Firefighters

FOR the purpose of amending the 2023-2024 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County through the U.S. Department of Homeland Security.

WHEREAS, the U.S. Department of Homeland Security has made an award of federal funds available to the Baltimore County Fire Department, to be used for three (3) vehicle acquisitions; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County

Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County

Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue
