We are requesting a recommendation from the LAC on the following request:

Transfer from the General Fund Contingent Account

Amount

To: Office of Administrative Hearings (OAH) – Data Practices and \$125,000

Election/Campaign Practices Hearing Expenses

OAH uses direct-appropriated resources from the general fund to provide for hearings related to data practices and election/campaign practices. Due to an unusually high volume of cases in FY 2023, the funding used for these matters has been depleted. OAH has no other funding available to reallocate to this purpose but is statutorily obligated to process these actions within specific timeframes. This funding will allow OAH to cover the cost until the full legislature can act. The requested funding would be disbursed from the contingent account in monthly installments as needed.
