Minnesota Laws of 2020, chapter 70, established a Health Care Response Fund and appropriated \$150 million to the commissioner of health for grants to health systems and facilities to aid their response to the COVID19 pandemic.
The law requires review by the Legislative Advisory Commission for any grants that exceed \$1 million. The attached lis grants meets the review requirement. The health care response law supports a variety of costs health care providers at facing in addressing the pandemic, including the need for additional staff and overtime emergency transportation, purchasing personal protective equipment, and testing equipment and supplies, among other needs.
The application process opened on April 14, 2020. The grant applications were reviewed by teams of staff with experies and expertise with the provider type. The applicants were prioritized based on urgency of need, high impact area, acti infections, financial need, reasonableness of request, need for preparation, and coordination of effort with other state regional COVID19 response efforts.
This is the second round of requests for use of the Pubic Health Response fund for grants greater than \$1 million.

Essentia Health is requesting funds to establish and operate temporary sites to provide testing, treatment beds, isolation or quarantine of affected individuals; convert space to negative pressure rooms; and purchase personal protective equipment.

The request meets the following allowable uses under the law:

- Temporarily convert space for another purpose that will revert to its original use.
- Pay support staff overtime and hire additional staff.
- Provide staff training and staff orientation.
- Purchase consumable protective or treatment equipment or supplies to protect or treat staff, visitors or patients.
- Develop and implement screening and testing procedures.
- Conduct patient outreach activities.
- Provide emergency transportation of patients.
- Support patient triage, screening, and telemedicine activities with additional temporary information technology and systems.
- Purchase specialty cleaning supplies for facilities and equipment.

HealthPartners, Inc. is requesting funds to expand screening at all sites, establish testing sites, including drive-up sites; staff respiratory care sites at existing primary care clinics; purchase personal protective equipment for all staff at these sites; use ultraviolet light machine to disinfect N95 masks; and retrofit space to isolate and care for COVID-19 patients needing inpatient care.
