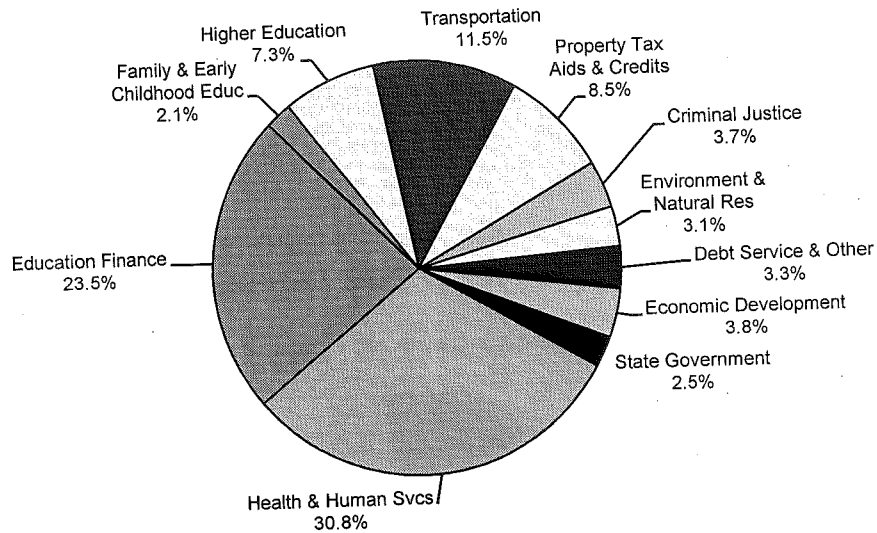


Total State 2000-01 Operating Budget November 2000 Forecast

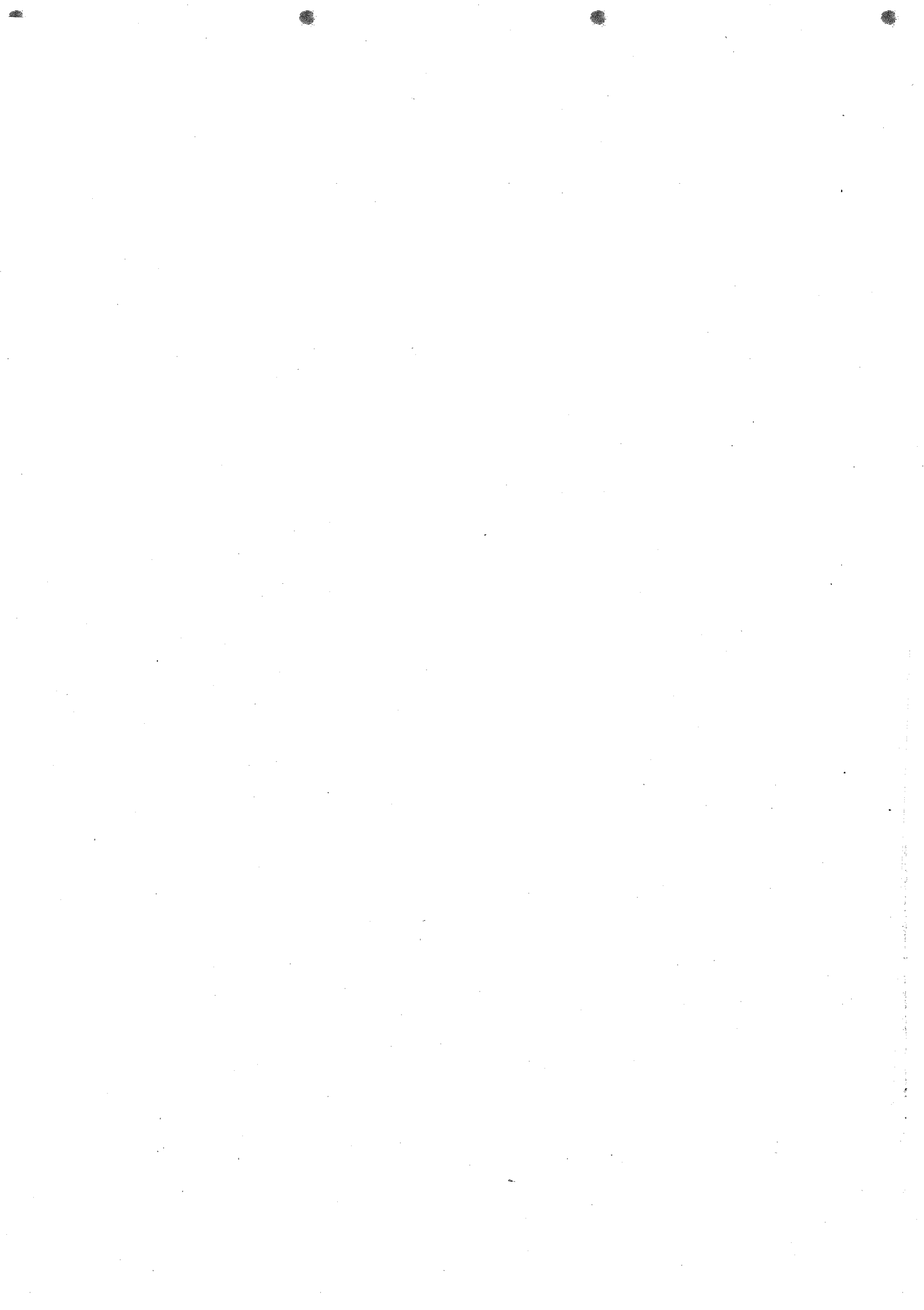
