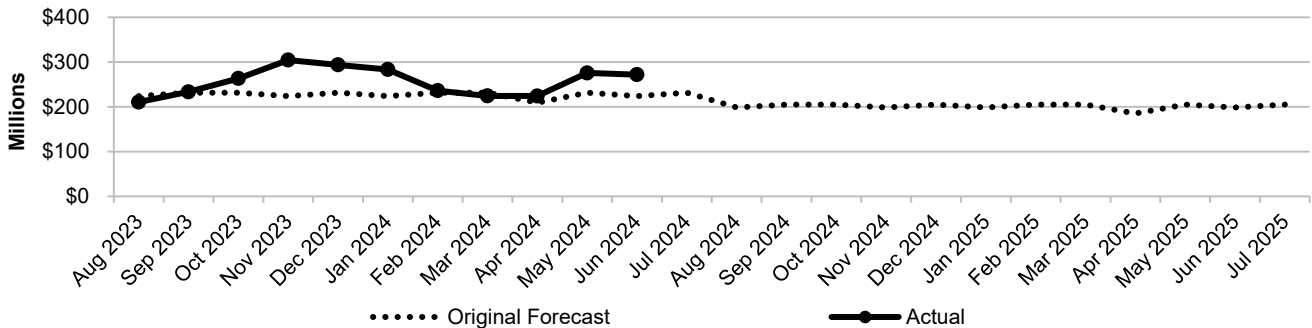
### OIL PRODUCTION AND PRICES
