

Trade Adjustment Assistance Act (TAA)

Helping workers whose jobs have been impacted by foreign trade return to good-paying work.

WERE YOU LAID OFF DUE TO FOREIGN TRADE ON OR BEFORE JUNE 30, 2022?

You may be eligible for benefits from the Trade Adjustment Assistance Act (TAA).

If you lost your job from a certified company due to offshoring or other foreign trade impacts, you may be eligible for re-employment assistance. (See list on next page.)



Up to 130 weeks of free training, which could include studying for a certificate or a college degree, getting on-the-job training, earning a GED/ESL certificate, and more.



One-on-one career counseling and support services.

Job search guidance, resume-writing assistance, and an array of other services offered at the American Job Centers.

Eligibility Requirements

You may be eligible for this assistance if:

- 1. You were laid off on or before June 30, 2022.
- 2. Your former employer is a **trade- impacted company** listed on the
 next page and you are included on
 a certified worker list.
- You are currently unemployed or underemployed without suitable employment.*

There is no cost to participate in this program. Once your form is reviewed, the TAA Unit at the Connecticut Department of Labor will follow up with you to confirm your eligibility and discuss next steps.

^{*}Suitable employment is defined as work that requires a substantially equal or greater skill level as compared to your trade-impacted employment, paying at least 80% of your average weekly wage.
