CARS PROJECT PROGRESS UPDATE PROJECT GOALS



- Provide a robust data-driven system
- Transform from paper-based forms processes to digital processes
- Enable users to effectively disclose or retrieve data
- Provide greater transparency into the political campaign finance and lobbying processes

CARS PROJECT PROGRESS UPDATE PROJECT GOALS (continued)



- Serve as official repository for filings
- Enable partner organizations to audit based on system of record filings
- Improve data visualization
- Allow enhancements as technology changes and new legislation is passed

NEW CAL-ACCESS PHASED GO-LIVE APPROACH



- February 2021: Initial Go-Live
- March through June 2021: Monthly releases
 - Additional releases of functionality are planned for the end of March, April, May, and June 2021
 - > Releases bring additional functions not initially released
 - > Releases help fix defects identified from initial release


