3. **If the defendant fails to comply** with the conditions of the bonds, the amount I deposited will be forfeited to the State of Alaska. The court will send me notice of forfeiture to the mailing or email address I give below.
4. It is my responsibility to notify the court if my email, phone number, or mailing address changes. *[Use form [TF-955](#).]*
