- Page 5, strike lines 25 and 26 and substitute "ENTERPRISE, CREATED IN
- 13 SECTION 25.5-4-402.4, THE MEDICAID EXPANSION, UNCOMPENSATED CARE,
- 14 AND UNDERCOMPENSATED CARE;".
- 15 Page 6, strike lines 7 through 10 and substitute "THAT THE STEERING
- 16 COMMITTEE SHALL NOT SHARE PUBLICLY ANY INFORMATION SUBMITTED
- 17 TO THE STEERING COMMITTEE THAT IS CONFIDENTIAL, IS PROPRIETARY,
- 18 CONTAINS TRADE SECRETS, OR IS NOT A PUBLIC RECORD PURSUANT TO
- 19 PART 2 OF ARTICLE 72 OF TITLE 24 EXCEPT IN AGGREGATED AND
- 20 DE-IDENTIFIED FORM.".
- 21 Amend reengrossed bill, page 7, after line 21 insert:
- "SECTION 2. In Colorado Revised Statutes, add 10-16-158 as
- 23 follows:
- 24 10-16-158. Hospital facility fee report data collection. THE
- 25 COMMISSIONER IS AUTHORIZED TO COLLECT FROM A CARRIER OFFERING A
- 26 HEALTH BENEFIT PLAN INFORMATION SPECIFIED IN SECTION 25.5-4-216, IF
- 27 AVAILABLE, FOR PURPOSES OF FACILITATING THE DEVELOPMENT OF THE
- 28 REPORT RELATING TO FACILITY FEES.".
- 29 Renumber succeeding sections accordingly.
