3 "(II) IF AN OWNER OF A MULTIUNIT BUILDING OR A MOBILE HOME 4 LANDLORD IS NONRESPONSIVE OR REFUSES TO ENGAGE WITH THE 5 BROADBAND INTERNET SERVICE PROVIDER IN REGARD TO THE AESTHETICS 6 OF THE PROPERTY, THE BROADBAND INTERNET SERVICE PROVIDER SHALL 7 INSTALL BROADBAND FACILITIES IN ACCORDANCE WITH HOW THE 8 BROADBAND INTERNET SERVICE PROVIDER HAS REASONABLY ASSESSED AS 9 MEETING THE AESTHETICS OF THE PROPERTY.".

10 Page 5, line 10, strike "AND".

Page 5, after line 18 insert: 11

12 "(XI) WARRANTS THAT THE BROADBAND INTERNET SERVICE 13 PROVIDER WILL NOT INTERFERE WITH OTHER SERVICES PROVIDED TO OR 14 USED BY THE MULTIUNIT PROPERTY;

15 (XII) INCLUDES A FULL DESCRIPTION OF THE AREAS OF THE PROPERTY WHERE EQUIPMENT RELATED TO THE BROADBAND FACILITY 16 17 WILL BE LOCATED THAT IS REASONABLY LIMITED TO ONLY THOSE AREAS 18 AS NECESSARY TO PROVIDE HIGH-SPEED BROADBAND INTERNET SERVICE 19 TO THE MULTIUNIT BUILDING, IS CONTAINED WITHIN EXISTING UTILITY 20 EASEMENTS WHENEVER POSSIBLE, AND IS SUBJECT TO THE PROPERTY 21 OWNER'S RIGHT TO DETERMINE THE LOCATION OF THE EQUIPMENT OR ANY 22 RELOCATION OF THE EQUIPMENT REQUIRED BY FUTURE DEVELOPMENT OF 23 THE PROPERTY;

24 (XIII) REQUIRES THE INSTALLATION MUST BE DONE IN 25 ACCORDANCE WITH INDUSTRY BEST PRACTICES, INCLUDING AESTHETIC 26 BEST PRACTICES, AND IN INCORPORATED AREAS, EXTERIOR 27 INFRASTRUCTURE MUST BE AT OR BELOW GRADE;

28 (XIV) REQUIRES THE BROADBAND INTERNET SERVICE PROVIDER 29 TO ASSUME ALL COSTS FOR DAMAGE RELATED TO CONSTRUCTION AS A 30 RESULT OF THE UNLOCATED PRIVATE UTILITIES ON THE PROPERTY; AND

31 (XV) REQUIRES THE BROADBAND INTERNET SERVICE PROVIDER TO 32 AVOID ANY DEVIATION FROM THE GENERAL AESTHETICS OF A BUILDING 33 WHEN INSTALLING ANY BROADBAND FACILITIES WHEN IT IS PRACTICABLE 34 AND DOES NOT CAUSE ANY UNDUE HARDSHIP ON THE BROADBAND 35 INTERNET SERVICE PROVIDER.".
