

**FACTS****WHAT DOES Credible Operations, Inc.****DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• <b>Social Security Number</b> and <b>Credit Scores</b></li> <li>• <b>Credit History</b> and <b>Income</b></li> <li>• <b>Employment information</b> and <b>Assets</b></li> </ul>	
<b>How?</b>	All financial companies need to share <b>Customers'</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>Customers'</b> personal information; the reasons <b>Credible Operations, Inc.</b> chooses to share; and whether you can limit this sharing.

## What we do

How does Credible Operations, Inc. protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Credible Operations, Inc. collect my personal information?

We collect your personal information, for example, when you

- **Apply for a loan** or
- **Give us your income information** or
- **Provide employment information** or
- **Open an account** or
- **Show your government issued ID**

**We also collect your personal information from others, such as credit bureaus, affiliates, or other companies**

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

**Your choices will apply to everyone on your account – unless you tell us otherwise**

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Credible Labs Inc., The Fox Family of Companies (including Fox Corporation)*

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Non-affiliated companies include financial services companies like lenders, service providers (such as appraisal and escrow companies), and certain marketing partners.*

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include credit card issuers and consumer finance lending institutions.*

## Other important information

### Notice to Vermont and North Dakota Residents

**We will not disclose information about your credit worthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to non-affiliated third parties to market to you, other than as permitted by state law, unless you authorize us to make those disclosures.**
