Billing for summer is a bit different to the rest of the academic year, so if you'll be continuing your studies through summer quarter, please pay special attention to the dates and deadlines listed below.

## WHAT IS COMING UP FOR SUMMER QUARTER?

### Registrar's Office

- If you're going to be enrolled in 10 units or fewer for Spring 2024, consider [applying for part-time study](#) to be eligible for reduced tuition. The deadline to apply is April 12.
- Register for Summer Session classes beginning April 15. Check your appointment time in WebReg now!
- Check the Fall 2024 Schedule of Classes to see what's offered and your enrollment appointment time on May 21.
- Register for Fall classes beginning May 24.

### Housing Dining Hospitality

- Undergraduate Campus Housing: Summer housing is billed monthly on the first of each month for the days of your contract within that month. As an example, a Summer Session 1 contract will receive charges in June, July, and August due to the contract spanning those three months. Cost & Payment Schedules for summer housing programs are posted on the [Summer Housing website](#) and include total program cost with monthly breakdown.
- Students who apply for and are approved for Extended Housing (current summer housing resident with a housing contract for 2024-25) will be billed in September for the additional cost of the Extended Housing program.
- Summer Housing billing schedule below:
  - June: 6/4/2024
  - July: 7/1/2024
  - August: 8/1/2024
  - September: 9/1/2024

- Costs may include students contracted in summer housing through September and/or students approved for Extended Housing program
- Students who are contracted for housing for Fall 2024-25 will also see their first quarter billing on 9/1/24 for Fall.
- Graduate & Family Housing:
  - Rent is billed monthly and visible on TritonPay on the 1st of every month (or the first business day after the 1st if the 1st falls on a holiday or weekend). Set up Autopay via TritonPay to avoid a late rent payment.
  - Students moving out of Graduate & Family Housing over the summer will see their rate prorated by the 1st of each month. The amount is calculated to reflect your approved move out date. Please contact your [housing community office](#) if you have questions about your move out charges.

## Financial Aid and Scholarships Office

- Financial Aid funds will be applied toward charges in TritonPay for [eligible students](#) beginning **June 22** for Session 1 and **July 27** for Session 2. Session 3 aid disbursement dates are based on the start date of your course(s). Any excess financial aid will be automatically refunded to you based on the timeline listed in the Student Financial Solutions section.
- Make sure to [commence academic activity](#) by participating in your classes by the end of week 1 of your summer courses to avoid any adjustments to your federal financial aid.

## Student Financial Solutions (SFS)

- **\*NEW\*** - Summer Session [Triton Registration Installment Plan \(TRIP\)](#) will now be offered for Summer Session 1, Summer Session 2, and Special Session. **Previous TRIP enrollment does not automatically renew.**

- **Financial aid disbursement may affect TRIP installment amounts, so we recommend completing your enrollment once all financial aid has been disbursed.**
- Excess financial aid refunds will be processed beginning on **July 1st for Summer Sessions 1 and 3, and August 5th for Session 2.**
  - Paper check arrives within 5-7 business days
    - [Enroll](#) in direct deposit to receive your refund faster and avoid potential delays with paper check
    - Direct deposit to bank account within 2-3 business days
- Don't forget to authorize new payers in [TritonPay](#).

## Student Health

- Student Health Office is open all summer for healthcare needs.
  - Monday, Tuesday, Wednesday and Friday from 8 a.m.-4 p.m.
  - Thursdays from 9 a.m.-4 p.m.

## June

- June 3 - TritonPay monthly eBill statement available
- June 22 - Session 1 Financial Aid Disbursements
- June 24 - Registration Fee Payment due for Session 1 and Special Session\*
- June 24 - Registration Fee Payment due for Session 1\*
- June 24 - Session 1 and 3 Financial aid refunds begin processing
- June 27- Students with outstanding balances of fees and tuition will be dropped from Special Session
- June 28 - Students with outstanding balances of fees and tuition will be dropped from Summer Session 1 classes

## July

- July 1 - First day of Session 1 classes
- July 2 - TritonPay monthly eBill statement available
- July 27 - Session 2 Financial Aid Disbursements
- July 29 - Registration Fee Payment due for Session 2\*
- July 30 - Session 2 Financial aid refunds begin processing

*\* Note: We recommend waiting until the monthly eBills are generated to ensure all relevant charges (including Housing) are on your account before making your payment.*

## August

- August 2 - TritonPay monthly eBill statement available
- August 2 - Students with outstanding balances of fees and tuition will be dropped from Summer Session 2 classes

- August 5 - First day of Session 2 classes
