## Update on journal activities since June 2021

- New co-editor, **Abel Brodeur** to the Board on August 1, 2021 and said good-bye (and thank you!) to two co-editors, **Charles Zheng** on June 30, 2021 and **Arthur Sweetman** on July 31, 2021. A big thank you to **Dan Bernhardt** and **Viktoria Hnatkovska** who will also be finishing their co-editor terms at the end of this month.
- A new incoming Managing Editor, **Zhiqi Chen**, has been appointed and will start July 1, 2022. Two new co-editors (**Marie-Louise Leroux** and **Stephen Williamson**) have also been appointed and will begin their terms July 1, 2022.
- The CJE's publisher (Wiley) gave notice to not renew the current contract which expires December 31, 2022. Wiley has proposed its terms for a new contract (including a move to an online only journal) and the actual terms are currently being negotiated.

- The journal experienced significantly publication delays this past 12 months. Our 2021 issues, our February 2022 and our Special Issue on Covid Economics (freely available) have now all been published and the journal's production is almost back on track.
  - A **joint CRDCN-CJE Webinar Series** has been established. Two webinars were held in 2021 and there is a commitment to host an annual Fall webinar going forward.
  - The **CJE Dataverse on Scholar's Portal** was created and is now being used to ensure compliance of all accepted papers with the journal's Data Availability Policy.
  - The journal will publish a special section on '**Reproducibility and Replicability in Economics**' guest edited by **Abel Brodeur**. An open call for papers is being planned for this Fall.



# Canadian Journal of Economics Paper Prizes

- **Harry Johnson Prize** awarded for the best paper published in the CJE the preceding year
- **Robert Mundell Prize** awarded to a “young” author or authors of the best paper published in the CJE the previous two calendar years.

# The 2021 Harry Johnson Prize

For the first time since the first two years of the prize being awarded, two papers have been selected by the committee. The winning authors are:

1. **D.L. Feir** and **Christopher Auld** for their paper “Indian Residential Schools, Height, and Body Mass Post-1930”
2. **Federico Ravenna** and **Marcus Mølbak Ingholt** for their paper “The impact of inflation targeting: Testing the good luck hypothesis”.

Vanderkamp Prize is for the best article each year. The runner-up for 2021 was “Material Deprivation: Measuring Poverty by Counting Necessities Households Cannot Afford” by **Geranda Notten** of the University of Ottawa and **Julie Kaplan** of Statistics Canada.

The winner of this year’s Vanderkamp Prize is “Recognizing Indigenous Rights in Canada: Property Rights and Natural Resource Values” by **Ian Keay** and **Cherie Metcalf**, both of Queen’s University. The paper studies responses in resource firms’ share prices to Supreme Court of Canada precedents involving Indigenous property rights.
