



# 2016 MINNESOTA FAMILY COUNCIL LEGISLATIVE SCORECARD

**Minnesota Family Council** tracked and scored legislators' votes on a number of issues affecting Minnesota families to show how they measure up to our pro-family principles. In our scorecard, we highlight nine votes in both the House and Senate which reflect legislators' pro-family or anti-family positions. We then tally the votes by individual legislators and calculate their overall score so you can identify your Family Friendly Legislators and Family Champions.

Family Friendly Legislators are those senators and representatives who have a 100 percent pro-family record on these critical issues.

## Family Champions

10 State Senators and 10 State Representatives were identified as Family Champions. These legislators have a 100 percent pro-family voting record, did not miss any scored votes, and also personally championed pro-family legislation. They were either the chief author of key pro-family legislation or offered a pro-family amendment to further pro-family values. Because of these faithful champions, pro-family values had a voice in the statehouse. Their commitment to family values deserves special recognition.

## What can you do?

First, we encourage you to review how your legislators voted and contact them. Either thank them for their pro-family votes or ask them why they voted against the family. You can find out who your legislator is and how to contact him or her by going to the legislative district finder at [www.mfc.org/elections](http://www.mfc.org/elections).

Second, inform others of where your current elected officials stand on the issues by forwarding this 2016 Legislative Scorecard. Finally, don't forget to pray for all our elected officials. As the Apostle Paul writes in 1 Timothy 2:1, "First of all, then, I urge that entreaties and prayers, petitions and thanksgivings, be made on behalf of all men, for kings and all who are in authority, so that we may lead a tranquil and quiet life in all godliness and dignity." Pray, too, that God would be merciful and provide our state with leaders who meet the biblical criteria of Exodus 18:21, those who are capable, fear God, are trustworthy, and hate dishonest gain.

# 2016 CHAMPIONS OF THE FAMILY

Though many of these legislators have championed more than one piece of pro-family legislation, below is listed one example of their commitment to pro-family values.

## MINNESOTA HOUSE OF REPRESENTATIVES



**Rep. Matt Dean**  
District 38B

Championed legislation to require an auditor review of University of Minnesota research activities that involved the use of fetal tissue. (2016 HF 3130)



**Rep. Tim Miller**  
District 17A

Championed the "Student Safety and Physical Privacy Act" to protect students' basic privacy and safety rights by requiring schools to maintain facilities separated based on biological sex. (2015 HF 1546)



**Rep. Glenn Gruenhagen**  
District 18B

Championed the "Individual's Right to Privacy and Safety in Public Accommodations Act" to protect the privacy, modesty, and safety concerns of the public by defining a person's sex as biological and prohibiting businesses, public schools, and universities from allowing access to restrooms, locker rooms, and dressing rooms except on the basis of biological sex. (2016 HF 3396)



**Rep. Cindy Pugh**  
District 33B

Championed legislation to prohibit taxpayer money for state-sponsored health programs from being used to fund abortions. (2015 HF 787)



**Rep. Debra Kiel**  
District 01B

Championed "Abortion Facility Licensing & Regulation" legislation to require all abortion facilities that are not already hospitals or outpatient surgery centers to meet the same licensing requirements as an outpatient surgery center. (2015 HF 606; 2016 House Journal, p. 7782) (Scored House Vote #1)



**Rep. Peggy Scott**  
District 35B

Championed legislation to establish the Legislative Commission to Study Surrogacy, a bi-partisan commission to study the health, ethical, social, legal, early childhood, business and other implications related to the practice of surrogacy in Minnesota. (2015 HF 437)



**Rep. Jim Knoblach**  
District 14B

Championed the "Fetal Tissue Research Practices" amendment to require the University of Minnesota to obtain institutional review board approval before conducting research using fetal tissue. (Amendment to 2016 HF 3237)



**Rep. Tama Theis**  
District 14A

Championed legislation to prohibit taxpayer money for state-sponsored health programs from being used to fund abortions. (2015 HF 607; 2016 House Journal, p. 7783) (Scored House Vote #2)



**Rep. Kathy Lohmer**  
District 39B

Championed legislation to defund Planned Parenthood by redirecting the state's family planning funding to community health clinics that provide comprehensive care and that do not offer abortions. (2016 HF 3374; 2016 House Journal, p. 7839) (Scored House Vote #5)



**Rep. Abigail Whelan**  
District 35A

Championed the "Born Alive Infants Protections Act" to ensure that babies born alive after a failed abortion receive medical care. (2015 HF 1047) For her leadership on this and other pro-family legislation, Rep. Whelan is the recipient of MFC's 2016 Family Champion Award.

Senate District 31

Championed "Abortion Facility Licensing & Regulation" legislation to require all abortion facilities that are not already hospitals or outpatient surgery centers to meet the same licensing requirements as an outpatient surgery center. (2015 SF 794)

Championed the "Individual's Right to Privacy and Safety in Public Accommodations Act" to protect the privacy, modesty, and safety concerns of the public by defining a person's sex as biological and prohibiting businesses, public schools, and universities from allowing access to restrooms, locker rooms, and dressing rooms except on the basis of biological sex. Championed legislation to allow volunteer Senate chaplains to pray according to the dictates of their conscience rather than follow a prescribed prayer requirement. (2013 Senate Journal, p. 1770) (Scored Senate Vote #9)

Championed legislation to keep "man" and "woman" references in marriage statute for marriages between opposite sex persons. (2013 Senate Journal 3584)

Championed legislation to require parental consent when the Education Department uses an intrusive student survey to gather information about non-academic topics, such as substance abuse and sexual activities. (2015 SF 979)



**Sen. Michelle Fischbach**

Championed "Abortion Facility Licensing & Regulation" legislation to require all abortion facilities that are not already hospitals or outpatient surgery centers to meet the same licensing requirements as an outpatient surgery center. **Sen. Warren Limmer**  
Senate District 34

Championed "Student Safety and Physical Privacy Act" to protect students' basic privacy and safety rights by requiring schools to maintain facilities separated based on biological sex. (2015 Senate Journal, p. 3167) (Scored Senate Vote #1)



**Sen. Paul Gazelka**  
Senate District 9

Championed legislation to protect the religious liberties of persons and organizations who object to providing goods, services, and facilities to perform, celebrate, affirm or sustain same-sex "marriages" based on sincerely held religious beliefs. (2013 Senate Journal, p. 3583) (Scored Senate Vote #8)

## KEY TO MINNESOTA HOUSE VOTES

- 1. License and Inspect Abortion Facilities.** A vote to require all abortion facilities that are not already hospitals or outpatient surgery centers to meet the same licensing requirements as an outpatient surgery center. MFC supported this amendment. (2016 House Journal, p. 7782; 2015 House Journal, p. 3791)
- 2. Prohibit Taxpayer Funded Abortion.** A vote to prohibit funding for state-sponsored health programs from being used to fund abortions. MFC supported this amendment. (2016 House Journal, p. 7783; 2015 House Journal, p. 3793)
- 3. Protect Student Data Privacy.** A vote to allow the Education Department to use an intrusive student survey to gather information about non-academic topics, such as substance abuse and sexual activities, without parents' explicit consent. MFC opposed this amendment. (2016 House Journal, p. 7707)
- 4. Exempt Non-profit Child Care Programs from State Licensing Regulations.** A vote to exempt non-profit child care programs from state licensure requirements. MFC supported this bill. (2015 House Journal, p. 4366)
- 5. Defund Planned Parenthood.** A vote to defund Planned Parenthood by redirecting the state's family planning funding to community health clinics that provide comprehensive care and that do not offer abortions. MFC supported this amendment. (2016 House Journal, p. 7839)
