### Inland SoCal 211+ Resource Database Inclusion/Exclusion Criteria

#### **Inclusion:**

- Government and verified private nonprofit 501(c) (3) organizations that provide or coordinate health, human and community-based services that have been in operation for at least one (1) year.
- Priority is free and low-cost services.
- For-profit organizations are considered on an individual basis. Inclusion is based upon uniqueness of service, lack of comparable services through nonprofit agencies or groups, and degree of need for the service and the level of subsidized, low income or sliding scale services available.
- Not for profit organizations or websites that provide socially beneficial services.
- Permanent local, state/provincial and federal disaster-related resources with a formal role in emergency response
- Services that emerge in response to a particular disaster or crisis to respond to the specific needs of the community.
- Urgent or specialty medical care facilities.

### **Exclusion:**

- We will not include organizations that deny services on basis of race, sexual orientation, religious belief, national origin, or that violate federal, state, or local laws or regulations.
- Organizations that misrepresent their services in any way.
- Organizations with incomplete applications.
- Organizations that do not update their information annually.
- Nonprofit organizations that do not effective contact person.
- Organizations that have been in existence less than one (1) year.
- Organizations that do not meet the inclusion criteria.
- Organizations that do not provide services to residents of San Bernardino or Riverside County.

## **Quality Control:**

• Inland SoCal 211+ reviews the inclusion exclusion criteria annually to ensure that it continues to meet the changing needs of the community.
