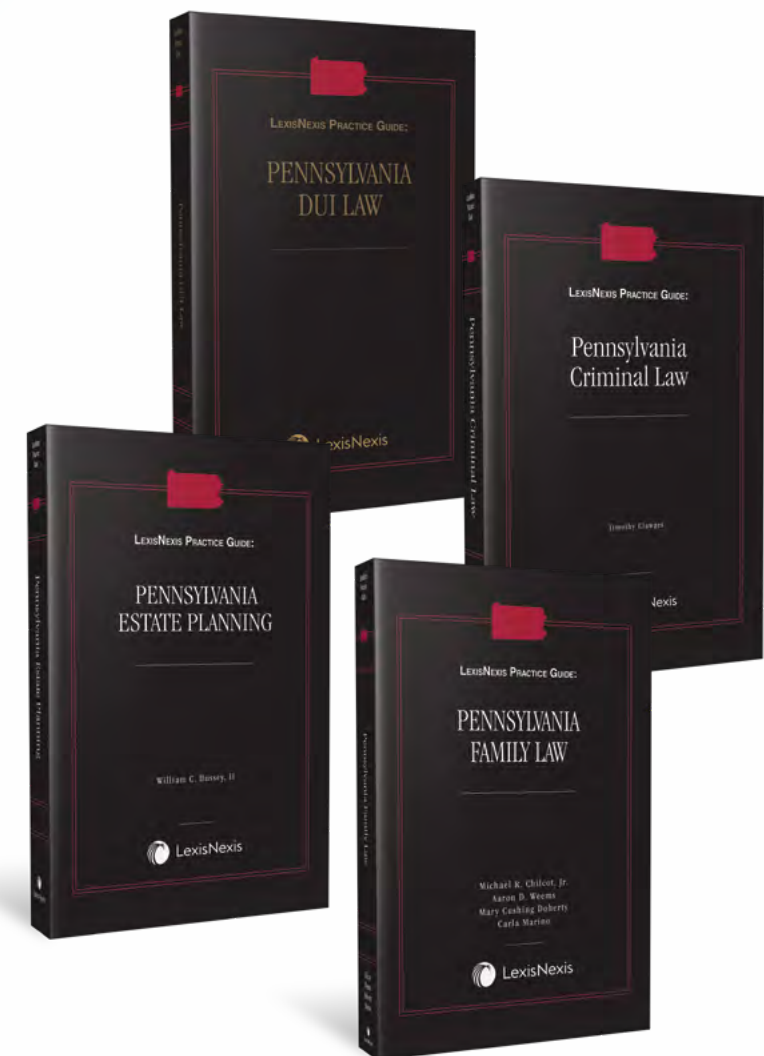

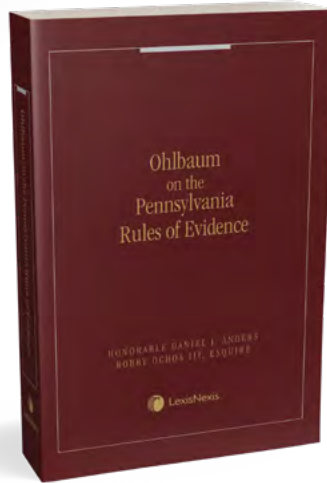
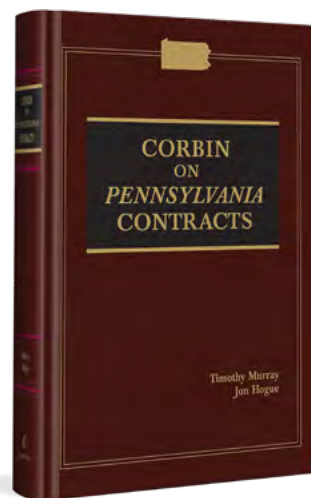
Corbin on Pennsylvania Contracts

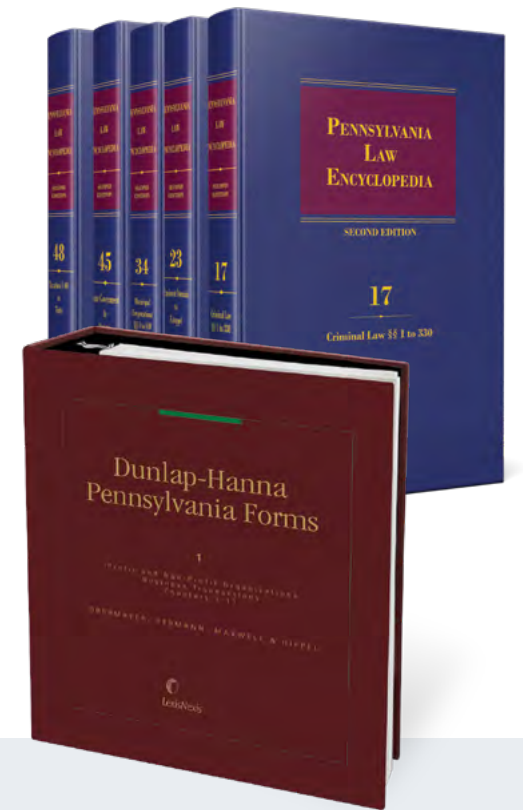
