1978 MOLES' AWARDS TO McNABB and McCLARY

JOE B. McNABB, President of Guy F. Atkinson Company headquartered at South San Francisco, California and James D. McClary, Board Chairman of Morrison-Knudsen Company Inc., headquartered in Boise, Idaho are the thirty-eighth pair to receive The Moles' Award for "Outstanding Achievement in Construction". The bronze plaques and hand engraved and illuminated citations will be presented to them at the Annual Award Dinner to be held on Wednesday evening, January 25, 1978 at The New York Hilton Hotel.

JOE B. McNabb was born in Cotter, Arkansas on December 21, 1913. He attended Grammar School in Cotter Arkansas; High School in Crane, Missouri and Southwestern College at Winfield, Kansas, enlisting for a four-year hitch in the U.S. Navy in 1934. He served on the USS SARATOGA. After his Naval (Continued on Page 2) James D. McClary was born in Boise, Idaho on July 19, 1917. He began his construction career with M-K in Oregon during the summer of 1932. The next summer he returned to work as a timekeeper on an Idaho highway job. Succeeding school vacations were spent as warehouseman and truck driver

service he continued his education majoring in hydraulics and civil engineering.

He joined the Guy F. Atkinson Company in 1942 as Engineer on the Alaska Barge Terminal Project: then spent two years on the Adak and Shemya Aleutian Island jobs. Since then he has had a wide range of construction experience on both domestic and foreign projects. Some of the more notable have been: the Dalles Dam in Oregon; Trinity Dam in California; Oroville-Wyandotte Project at Feather River, California; and the huge Mangla Dam in West Pakistan. The Mangla Dam Project, constructed for the Water & Power Development Authority of West Pakistan included Mangla Dam, an 11,000 foot long earthfilled dam of some 75 million cubic yards; the world's largest spillway, containing some 1.2 million cubic yards of concrete; the "small" Jari Dam, which alone contained 38 million cubic yards of material; and the powerhouse, five tunnels, canals and dikes. In total the project included some 200 million yards of excavations and 2 million yards of concrete.

After the completion of Mangla Dam, he was appointed Manager of Atkinson's International Division, then Manager of the Company's Heavy Construction Division. In 1968 he was elected Vice President, a Director in 1969, Senior Vice President in 1971, General Manager in 1973 and President in 1975.

on a road project in Yellowstone Park, then clerk and timekeeper on M-K canal projects in Nebraska.

In 1938 he graduated at the age of 20 from Stanford University with a Bachelor of Arts degree in civil engineering and advanced rapidly through a series of M-K field projects as an engineer. foreman, superintendent and project manager on dam contracts and as an executive of M-K subsidiary companies in Mexico. In 1951 Jim returned to Boise, Idaho to become assistant to the company's General Manager. He was subsequently advanced to Assistant General Manager, Director, Vice President, Executive Vice President and was elected Chairman of the Board in June 1972.

During the early 1950's he was assigned as a member of the operating committee of Atlas Constructors, an M-K sponsored joint-venture of five contracting companies building five huge U.S. Air Force bases in French Morocco under a contract with the Army Corps of Engineers. Military construction projects have had a major role in his long career with M-K. Over the years he has been involved with the construction of Military Cantonment, Fort Ord, California and Fort Huachuca, Arizona; the Naval Gun Relining Facility, Idaho: Casper Air Base, Wyoming: Gunnery School, Yuma Air Base, Arizona; Otav Naval Air Station, California; and the Sanalona Dam and Morelos Dam both in Mexico.

In addition to his activities in the M-K Company, he has held important positions with the Associated General Contractors of America culminating with his installation in 1972 as National President.

A veteran of forty-five years in the construction industry, Jim has more recently directed his activities as a spokesman to assist the Industry with its many current day problems.

IRVING S. SHAPIRO, Chairman of the Board and Chief Executive Officer of the Du Pont Company will address The Moles and their guests on the evening of January 25th on the occasion of the annual Award Dinner.


Born July 15, 1916 in Minneapolis, Minnesota, Mr. Shapiro is the oldest of three sons of Lithuanian immigrants. He was graduated from the University of Minnesota with a bachelor of Science degree in 1939 and received his Bachelor of Laws degree from the same university two years later. He was admitted to the Bar in Minnesota in 1941 and in 1944 was admitted to practice before the United States Supreme Court. He was admitted to the Delaware Bar in 1958.

Mr. Shapiro joined DuPont in 1951 as an attorney in the Legal Department after serving in the U.S. Department of Justice during the Roosevelt and Truman Administrations. He is the first person in the 175-year history of the firm to rise to the top through a career in law. The Company's twelve previous Chief Executives all had backgrounds in Science, Engineering or Finance.

His work in the Legal Department emphasized antitrust litigation and providing counsel to various manufacturing departments of a wide range of business problems. He played a major role in the antitrust case of the 1950's and early 1960's which forced Du Pont to divest itself of General Motors stock.

David has been exposed to every phase of construction since his high school days working summers from 1953 to 1961 in many capacities both in the field and in the office.

Graduating from the College of The Holy Cross in 1959 with a B.S. degree he went on to Boston College Law School and earned his LL.B. in 1962. He joined Perini Corporation as Assistant to the General Counsel and served in that capacity until 1965. JOHN A. LAMBERT died July 2, 1977 at the Mid-Maine Medical Center, Waterville, Maine.

Mr. Lambert was former Vice President and director of McKiernan-Terry Corp., having merged the Lambert Hoisting Engine Co. with McKiernan-Terry in 1931. He directed the Lambert and Mead-Morrison Divisions of the Corporation until his retirement in 1958.

He was a graduate of Newark Academy and the Newark College of Engineering. A native of New Jersey born in Newark, he resided for many years in Montclair.

Mr. Lambert was a Charter Member of The Moles having been elected in 1938. When he retired from business in 1958 he was elected a Member Emeritus.

He is survived by three daughters, Miss Mary Lambert, Mrs. Ruth Weston and Mrs. Ann Jones; a brother, Prall W., ten grandchildren and a great-grandchild.

He was Director General Alumni Association 1973-76; Associate Trustee 1976; and was elected to The Holy Cross Board of Trustees in 1976. He is also a member of the Italian American Charitable Society; Friends of the Cardinal 1976; and a corporator of New England Deaconess Hospital 1971.

During 1973 he received the Ten Outstanding Young Leaders Award from the Boston Jaycees.

WALTER F. CONLIN, SR., died on April 29, 1977 after a long illness. Mr. Conlin was a part of Turner Construction Company for 47 years until his retirement in 1966.

Graduating from Worcester Technology's school of Civil Engineering in 1917 he spent two years with the Federal government. In 1919 he joined Turner Construction Company as a Line and Grade Man. From 1923 to 1929 he managed his own business and subsequently returned to Turner as an Assistant Superintendent. During the depression he spent two years in the Boston area working with other construction firms, again returning to Turner in 1934. He became a superintendent in the New York office. In 1953 he was named General Superintendent and some time later the title of Project Manager followed.

He had project management responsibilities on jobs for State Mutual Life, General Electric and LaGuardia Airport for the Port of New York Authority. Walter was a "true construction man" thoroughly enjoying the challenge of the projects he supervised.

He is survived by three sons, Walter Jr. (a Mole member since 1968), Theodore and Leonard; fourteen grandchildren and one great-grandchild.





He is survived by his wife, Thelma; and a sister, Mrs. Martin Wensley.










MOLES' NEW QUARTERS
