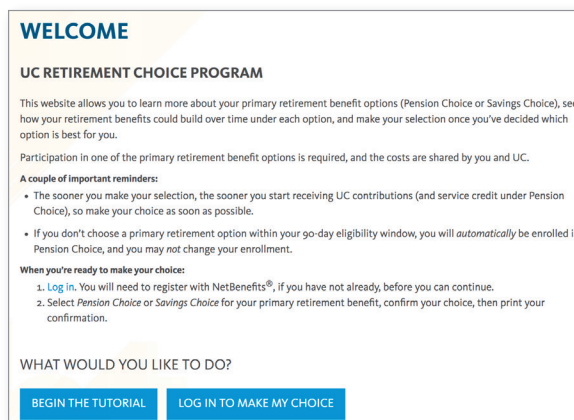


UC RETIREMENT CHOICE PROGRAM—STEPS FOR ELECTING PENSION CHOICE OR SAVING CHOICE

1. GO TO myUCretirement.com/choose

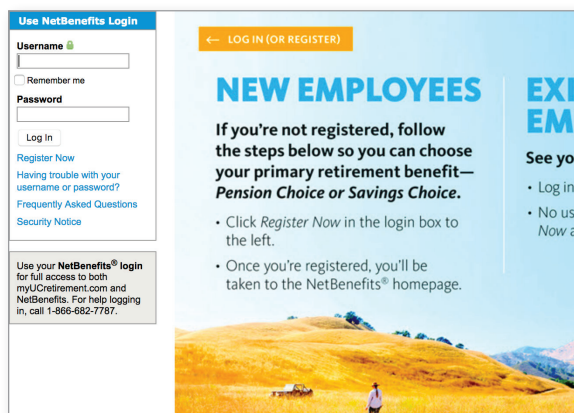
On the WELCOME page, click the blue button,
LOG IN TO MAKE MY CHOICE.



2. REGISTER AND LOG IN TO NETBENEFITS

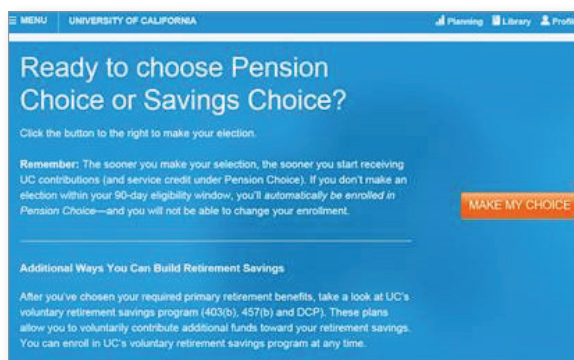
In the NetBenefits login box, click *Register Now* and follow the instructions to complete the registration and login process.

(If you already have a NetBenefits username and password, simply log in and you'll proceed automatically to step 4.)



3. CONTINUE ON TO YOUR ELECTION

After you've logged in, you will see this screen. Click the orange button, *MAKE MY CHOICE*, to continue on to your election.



4. MAKE AND CONFIRM YOUR CHOICE

There are several steps before you confirm your choice, with the option along the way to return to the tutorial for more information. Here are the steps:
