2. INTRODUCTION

The subject area Public International Law aims to teach students about the laws that govern international society, how the international legal system works and how it relates to national systems.

Students will also learn about the major international organisations responsible for creating and enforcing these laws.

We will focus particularly on the law governing the State, land, air and sea and its relationship with supranational law, as well as the sources of public international law.

3. SKILLS AND LEARNING OUTCOMES

Basic skills (CB, by the acronym in Spanish):

- CB1: Students have demonstrated possession and understanding of knowledge in a study area
 that builds on general secondary education, and is typically at a level that, while supported by
 advanced textbooks, also includes aspects that involve knowledge from the forefront of their field
 of study.

- CT04 Communication skills: Students should be able to effectively express concepts and ideas, as well as possess clear and concise written communication skills and effective public speaking skills.
- CT05: Interpersonal understanding: Students should be able to actively listen for the purpose of reaching agreements, using an assertive communication style.
- CT06: Flexibility: Students should be able to adapt and work in different and varied situations with different people. This involves assessing and understanding different positions and adapting their own approach according to the situation.

Specific skills (CE, as per the Spanish acronym):

- CE01: Know and understand the components, structure, resources, interpretation and application of the legal system, and interpret the sources and fundamental legal concepts of the different legal systems.
- CE12: Develop critical awareness in the study of the legal system.
- CE13: Understand how legal institutions work.
