## 2. INTRODUCTION

The overall aim of 'LABOUR LAW 1' is to introduce students to basic concepts of labour law: the sources, contractual arrangements, performance of work, working hours and breaks, provision of pay, the termination of the contract and other affairs, as well as other rights and obligations of workers.

## 3. SKILLS AND LEARNING OUTCOMES

#### Basic skills (CB, by the acronym in Spanish):

- CB1: Students have demonstrated possession and understanding of knowledge in a study area that builds on general secondary education, and is typically at a level that, while supported by advanced textbooks, also includes aspects that involve knowledge from the forefront of their field of study.
- CB2: Students can apply their knowledge to their work professionally and possess the necessary skills, usually demonstrated by forming and defending opinions, as well as resolving problems within their study area.
- CB3: Students have the ability to gather and interpret relevant information (usually within their study area) to form opinions which include reflecting on relevant social, scientific or ethical matters.
- CB4: Students can communicate information, ideas, problems and solutions to both specialist and non-specialist audiences.
- CB5: Students have developed the learning skills necessary to undertake further study in a much more independent manner.

## Cross-curricular skills (CT, as per the Spanish acronym):

- CT1: Responsibility: Students should be able to accept the consequences of and take responsibility for their own actions.
- CT2: Self-confidence: Students should be able to act with confidence and with sufficient motivation to achieve their objectives.



- CT4: Communication skills. Students should be able to effectively express concepts and ideas, as well as possess clear and concise written communication skills and effective public speaking skills.
- CT5: Interpersonal understanding: Students should be able to actively listen for the purpose of reaching agreements, using an assertive communication style.
- CT6: Flexibility: Students should be able to adapt and work in different and varied situations with different people. This involves assessing and understanding different positions and adapting their own approach according to the situation.

### Specific skills (CE, as per the Spanish acronym):

- CE1: Know and understand the components, structure, resources, interpretation and application of the legal system, and interpret the sources and fundamental legal concepts of the different legal systems.
- CE4: Interpret legal texts from an interdisciplinary perspective, applying legal principle as well as social, ethical and moral principles and values as tools for analysis.
- CE8: Skilfully and accurately use the legal language and terminology used in different areas of law. Write up legal documents, ensuring they are orderly and understandable. Use written and spoken communication to express ideas, legal arguments and reasoning using the appropriate register for the context in question.
- CE9: Use information and communication technology to search for and find legal information (legislation and case law databases, literature, etc.), as well as work and communication tools.
- CE10: Contribute towards the maintenance and functioning of employment relations.
- CE12: Develop critical awareness in the study of the legal system.

### Learning outcomes (RA, as per the Spanish acronym):

- RA1: Interpret special sources of labour law and their particular features in relation to the rest of the legal system.
- RA2: Knowledge of the parties involved in labour relations and individual/collective relations in companies.
