2. INTRODUCTION

Administrative Law 3 is a compulsory subject area in the Bachelor's Degree in Law and double degrees in the faculty of Social Sciences. It is delivered in the third year and builds on the knowledge of public law acquired from previous subject areas.

The subject of study is the so-called body of economic administrative law and the government's involvement in the economic sphere, with special focus on the regulation and controls of public law to ensure the market remains functional.

3. SKILLS AND LEARNING OUTCOMES

Basic skills (CB, by the acronym in Spanish):

- CB1: Students have demonstrated possession and understanding of knowledge in a study area
 that builds on general secondary education, and is typically at a level that, while supported by
 advanced textbooks, also includes aspects that involve knowledge from the forefront of their
 field of study.
