# 2. INTRODUCTION

The overall aim of the subject area 'Labour and Judicial Review Procedural Law' is to introduce students to the study of two of the essential jurisdictional orders—Labour and Judicial Review—in order to employ their professional skills and abilities in their future career in the area of justice.

In this regard, the Labour and Judicial Review processes are two instruments at society's disposal for resolving conflicts that arise within these areas, either between employers and workers, between citizens and public bodies, or between different public bodies themselves.

Students will study the elements within the subject area in terms of theory and legal setup, as well as aspects of judicial practice and case law, so that they are aware of the instruments used in professional practice in the specific areas of Labour and Judicial Review Procedural Law in any jurisdiction.

# 3. SKILLS AND LEARNING OUTCOMES
