## 2. INTRODUCTION

The subject area Civil Law 5: Succession Law is a compulsory subject area within the Bachelor's Degree in Law, where students will learn the basics about the organisation of a person's estate after death and whether legal systems should establish rules on the succession of the deceased's estate. Students will learn about the way in which a person can create their last will and testament in order to organise their succession.

We will study wills, heirs, capacity to inherit, substitutions, forced heirship, legitimate succession, 'la mejora', legacies, partition of the estate and intestacy.

### 3. SKILLS AND LEARNING OUTCOMES
