print specifications - color settings

downloading ink settings

1. Visit: https://www.theadvocate.com/site/ink_settings_advocate.html (link is clickable here)
2. Download the custom ink settings for all our newsprint publications (.csf file) to your desktop or a folder for later use.
3. (Adobe Software) In the top menu bar, click **Edit > Color Settings** (steps are the same for Photoshop and InDesign).
4. Click load and navigate to the location of your file and click open; then click OK.
5. Click **Edit > Assign Profile**.
6. In **Photoshop**: choose the middle option for "**Working CMYK: GambitInkSettings**"; click OK.
7. In **InDesign**: choose the middle option for RGB Profile "Assign current working space: sRGB IEC61966-2.1" for CMYK Profile choose "**Assign current working space: GambitInkSettings**." Click OK.
8. Create a new file using the file sizes provided.
9. Design your ad.

things to keep in mind while designing

1. **Only CMYK or Grayscale color range files are accepted** - (Pantone, Spot and RGB will be converted accordingly)
2. **No rich black for text** - For black text, only use 100% black (no rich black)
3. **All text is at least 8 points in size** - If your text is not 100% black and is on top of any color but white (referred to as knock-out text), it must be at least 12 points and bold without any thin strokes or serifs. Avoid any ornate script fonts especially in knock-out situations.
4. **Your files are flattened** - Make sure when placing logos and images used are flattened files. Do not place layered logos or images. Design your ad.

exporting your ad

1. Be sure to **name your files clearly** including the client name and date:
- **Good: HarrysShop_6-13-15.pdf**
- **Bad: 0942523AXD-Advocate.pdf**
2. **If your ad was made in Photoshop only** - save the document as a .psd, then flatten it, then save it as a Photoshop PDF (make sure "**Embedded Color Profile: GambitInkSettings**" is checked at the bottom). Don't overwrite your original layered file. Saving it as a different file will keep your original file unflattened in case more changes need to be made. High quality photoshop JPEGs are also accepted.
3. **If your ad was made in both Photoshop and InDesign** - Save your photoshop documents, relink any files in InDesign. Make sure text is 100% Black with no other colors, convert text to outlines and export using File > Adobe PDF Presets > [PDF/X-1a:2001]... and submit your ad. (Remember to un-outline your font before you save your file so the text will still be editable if there are any typos.)

preprints - packaging requirements

1. **SUPPLEMENT SIZE** - Preprinted supplements must be at least 5" x 7" and not larger than 19.5" x 12"
2. **PAPER WEIGHT** - Minimum 30 lb. stock - Tabloid; Minimum 60 lb. stock - Single Sheet
3. **SKIDS** - Skids must be solid base with solid runners. Skid top should be wood and must conform in size to skid base. Deck must be covered in cardboard before loading to prevent curling. Shrink-wrapped skids must have protective corners to prevent crimping.
4. **STACKING** - Supplements must be brick stacked in convenient lifts (6" - 12") well jogged with no turns. Supplements should be stacked so that most folded edges are turned toward the center of the skid. Cardboard tie sheets must be used between each tier and on top to prevent distortion. Supplements must be recessed a minimum of 1/2" from the skid edge (all sides) to prevent crimping. DO NOT tie supplements together in bundles. Skids must not exceed 5 1/2 feet in height, must contain the same number of copies (except for the last), and must contain a skid tag indicating product and number of copies.
5. **DELIVERY** - The shipping and receiving dock hours are 6:00 a.m. to 3:00 p.m., Monday through Friday. Deliveries cannot be accepted outside of those times. The Times-Picayune, Baton Rouge Advocate and Acadiana Advocate daily and Sunday paper deadline is 11 business days prior to run date. Baton Rouge community papers (Zachary Plainsman, Mid-City, Southside, Southeast, Ascension and Livingston-Tangipahoa), New Orleans community papers (Crescent City, West Bank, East Jefferson and St. Tammany) are 9 business days prior. All inserts should be broken out and labeled according to edition. Earlier deadlines apply for holidays. Contact your sales representative for details. A proper bill of lading must accompany all shipments and should indicate (1) Advertiser, (2) # of skids and (3) # of copies. Supplements must be shipped prepaid to:
