Financial Consequences

Richard*, a successful, 45-year old corporate executive, began gambling to deal with boredom and loneliness after his marriage ended abruptly in divorce. His healthy financial condition enabled him to gamble for many years with seemingly little consequence. Over time, however, the money ran out, the credit ran up, the house went into foreclosure and his depression accelerated. His financial, emotional and physical health deteriorated along with his work performance. After losing everything he had worked over 20 years to earn, the company decided to let him go but provided him with a substantial severance pay which he quickly lost through continued gambling. (*Not his real name)

Financial issues are often the first outward sign of a gambling problem. When gambling becomes uncontrollable, the problem gambler will spend even more money, attempting and usually failing, to win back their losses. Here are some of the financial consequences that may occur:

- Overdue bills
- Maxed out credit cards / Denial of credit
- Always short of money, despite adequate income
- Cannot provide for basic needs (food, clothing, shelter)
- Relies on borrowing money from friends, family or coworkers
- Develops a pattern of extremely high-risk investing or frequent trading
- Money is pulled from home equity, savings, investment or retirement accounts
- Household and personal items are pawned or sold for cash
- Frequent, multiple payday loans or cash-advances
- Property is repossessed
- Home is in foreclosure

Many problem gamblers believe that money is both the cause of, and the solution to their problems, so they continue to gamble in spite of the losses, believing they can fix all the problems with just one more 'big win'. Sadly, there can never be a big enough 'win' to solve the problem of the addiction, because it is an emotional illness, not a financial one.

For this reason, the real solution is for the gambler to deal with their addiction, not just the money problems it creates. Treatment and support resources can help the gambler stop gambling, and with abstinence from gambling, the stress from financial pressures will begin to be relieved. Long term solutions will require hard work, debt repayment and careful planning but the finances of a problem gambler and their family can recover over time.



Wisconsin Council on Problem Gambling, Inc. 2019 Year in Review

he year 2019 was the 21st year of our Compulsive Gambling Public Awareness Campaign. It was our 26th year in operation and the 24th year of the 24-hour Helpline. The Council continued to see tremendous growth during the past year.

The Public Awareness Campaign contains five different project areas used to enhance the awareness of Problem and Compulsive Gambling. These areas include the 24-hour Helpline, High School Educational Curriculum, Statewide Compulsive Gambling Awareness Conference, our Public Relations Media Awareness Campaign, and the Training of Human Service Professionals.



24 Hour Helpline

The Helpline received 12,283 calls in 2019 with the highest months of calls being April and December with 1,150 calls. We continue to receive many hits to our website annually. We received 11,951 web hits in 2019. The highest month was March with 3,200 hits. The average debt amount of calls to the Helpline was \$20,714. However, many people refuse to divulge this information and are confused about their indebtedness. Area code 414 received the most calls. During the year 2019, 359 referrals were made and 52 packets of information were sent. The chat line received 81 chats and the text line received 8 texts.

Outreach Program

The WCPG provides an Outreach Program. This program provides educational sessions to high school students around the state. The goal of the program is to provide education and awareness on gambling disorders. Students learn the definitions of gambling, the risks associated with gambling, the warning signs, and how to get help for themselves or others. Presentations in schools throughout the state continue. The Outreach program reached 1,807 students and 34 staff through 69 classes in 2019.

State Wide Compulsive Gambling Conference

The WCPG hosted its 20th Annual Wisconsin Council on Problem Gambling Statewide Conference on March 14-15, 2019, at Blue Harbor Resort in Sheboygan, WI. A total of 138 people attended the two day conference.

Training of Human Service Professionals

We have been able to provide two Phase I and Phase II training sessions during 2019. One intro training was held in Green Bay. A total of 66 training units were provided through our training sessions. There were approximately 300 attendees who participated in other trainings and workshops throughout 2019. A Department of Corrections training was held. There were 45 participants. The WCPG will be hosting several intro trainings and Phase I-IV during 2020.

We continue to develop a list of all persons/agencies within the state of Wisconsin qualified to provide training, education, treatment, or public information at various levels for use by such groups as Employee Assistance Programs, human resource personnel, AODA personnel, school counselors, treatment providers, and civic and church groups.

Public Relations/Media Campaign

As part of the media awareness campaign, the following has been accomplished or continues:

- Planning, development, and implementation of the public awareness campaign--phase twenty-one.
- ♦ The WCPG continues to develop a list within the State of Wisconsin with persons/agencies qualified to provide training, education, treatment, or public information at various levels on the issue of compulsive gambling.
- Continued distribution of twelve different posters.
- The WCPG increased its social media presence through Facebook, Instagram, Pinterest, You Tube, LinkedIn, and Twitter.
- One-on-one media interviews in the state's five main media markets.
- ♦ More than 500 media contacts including newspapers, radio, and television.
- Press releases regarding the WCPG effort were distributed.
- ◆ Continued distribution of "Is Gambling Affecting Your Life?" (Approximately 180,000 have been distributed)
- Exterior bus signage continues in several cities throughout Wisconsin.
- Bathroom ads in Wisconsin Casinos.
- Exhibits at a variety of conferences and programs throughout the state.
- ♦ Tokens, magnets, pens, pencils, note clips, back scratchers, calendars, oven sticks, and computer dusters, etc. are being distributed in a variety of ways throughout Wisconsin. These public awareness "tools" are an excellent opportunity to get the 800-Helpline number out to thousands of people. People will pick up a pen, which has the 800 number on it, more likely than they would pick up a pamphlet.
- Continued partnership with the Wisconsin Lottery.
- Increased materials in our resource library.
- Continued distribution of WCPG brochures including "special population" brochures.
- Continued distribution of membership brochure.
- Continued development of a data collection process for a book of experts.
- Reached an estimated 34,000 people through contacts at exhibits, workshops, and conferences.
- WCPG continues to speak to a variety of groups—EAP, social service departments, counselors, people working
 with the elderly, Dept. of Corrections, etc. to provide education and awareness on the compulsive gambling
 addiction.
- WCPG continues to distribute our quarterly newsletter to over 5,500 people.
- ♦ A workplace brochure continues to be distributed to generate more awareness in the workplace environment.
- A legislative newsletter is distributed quarterly to all Legislators in Wisconsin.
- A brochure geared towards parents continues to be distributed.
