# **Creating Cost-Share Programs to Accelerate the Adoption of Sustainable and** Resilient Chicken Farming Practices in the Delmarva Peninsula (DE, MD, VA)

### DCA's Mission & Background

To be the Delmarva chicken industry's voice as the premier membership association focusing on advocacy, education and member relations.

DCA is the 1,600-member trade association working for the common good of the meat chicken industry in Delaware, the Eastern Shore of Maryland and Virginia's Eastern Shore. Our membership includes chicken growers, chicken processing companies and allied businesses that service the chicken industry. We are a non-profit association governed by a Board of Directors.

#### **Project Overview**

DCA has been awarded a grant from the National Fish and Wildlife Foundation for Innovative Nutrient and Sediment Reduction. This grant will enable DCA to collaborate with partner organizations to create cost-share programs for the adoption of agricultural conservation practices on chicken farms and associated lands. By supporting the implementation of best management practices outlined in the Chesapeake Bay model, these programs will contribute to achieving regional water quality targets.

## **Project Objectives**

DCA is seeking qualified nursery and landscape professionals to implement conservation practices that prioritize regionally native tree, woody shrub, grass, and pollinator plantings as well as agricultural conservation best management practices that improve soil and water quality in the Chesapeake Bay region. Interested businesses should be familiar with Natural Resource Conservation Service (NRCS) program standards and practices.

DCA will compile a list of interested/qualified businesses for grantees/farms to work with for the implementation of these projects. Since many businesses may be limited in costs by travel/distance, DCA is seeking interested businesses from across the Delmarva Peninsula, so that farms in each area of the peninsula can have access to qualified resources to implement these programs.
