2021-2022 OSTP Summer Camp Update:

- We are excited to transition back to our pre-covid operations and the future looks great.
- Summer Camp registration is in motion with 483 campers enrolled as of 3.11.22.
- Nine elementary school-aged sites and one middle school-aged site are available across the City.
- Pre-registration went smoothly as we served 118 families who qualified for financial assistance.
- We hope ACPS will provide bus transportation to our fantastic swimming pools, local amusement parks, and our annual “Marvelous Monday” end-of-the-summer extravaganza!

Program Wrap-ups:

- On February 25, the Patrick Henry Recreation Center held the **Black History Cookout**. The program featured black history facts, trivia, music, 2 dance performances from our youth participants and food. There were 46 participants that attended the program.



- On February 17, the OSTP held its **Black History event** for our youth. The program featured songs and dance performances from our youth participants and the guest speaker was Mr. Michael Johnson.



- On February 25, Patrick Henry Recreation Center held it's **Nerf the Turf** program. The program was offered to ages 7-12, and focused on teamwork development, problem-solving, and sportsmanship skills. 28 participants had a great time and worked as a team to come up with strategies to win battle.



- The William Ramsay Recreation Center co-sponsored a **family movie night** with the William Ramsay PTA. This free screening of “Encanto” for the community brought in over 200 participants to watch, sing, and dance their way through the popular film.



- The students at the William Ramsay Recreation Center’s Out-of-School time program wrapped up their piano lessons with **Learn Now Music**. Students had a great time learning about melody, beats, notes, and chords. They especially loved hammering away at their keyboards and bringing music to life. Next, students will be treated to Silver Knights, a program that will teach the students the fundamentals of chess.

- On March 2, participants of the William Ramsay Recreation Center’s Out-of-School Time program participated in a Dr. Seuss scavenger hunt in honor of **Read Across America Day**. Students had a great time finding different books and reading the exciting stories.
- The William Ramsay Recreation Center supported the City’s efforts to distribute **COVID testing kits** to targeted communities. Through multiple distributions, the center was able to provide 850 testing kits. The remaining 150 kits from the allotted 1,000 were given back to the city to support early childcare centers.

Program Updates:

- \$550,804.78 in revenue, and 21 camps already filled.
- Youth basketball league is coming to an end with the championship games scheduled for Saturday, March 19. This season 976 participants played on 106 teams.
- The Mt. Vernon Recreation Center had a great turn out for Read Across America on March 2. Special thanks to the following readers. Mr. James Parajon, Margert Orlando, William Chesley, Skyler Borman and Adric Shern.
- On February 3, Patrick Henry Recreation Center held its first Circle of Girls Teen Club meeting. This mentoring program allows teens to explore their distinct voices and pursue their dreams and passions, which helps build self-confidence. The program meets each Thursdays at 6:30pm, and currently has 22 participants.



- During the month of February, youth ages 6-12 participated in Lego Lab at Patrick Henry Recreation Center. Lego Builders Unite! This is the perfect challenge for the creative builder. The youth participants had the opportunity to build LEGO models to their hearts content or go off the grid and explore their creative side.

- Durant Center - Join us as we celebrate the Oscars! **Oscar-winning movies** will be shown on Friday March 25th and Saturday March 26th, free for the community. Bring your snacks and enjoy the movies with us! Fee is \$9/child, pre-registration required.

- **Spring Break Camps** - Spring Break Camp registration is open now for multiple locations and camps. These camps cover a variety of fun activities including aquatics, sports, arts, and science, and offerings are available for kids ages 3.5-14. Spring Break is April 11th-April 15th.

- Repaired and replaced play equipment at Windmill Hill playground.

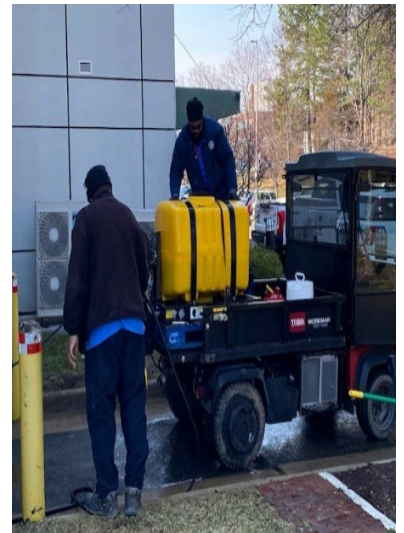
2. URBAN FORESTRY & HORTICULTURE

c. Environmental Review

- Staff reviewed the Alexandria Renew Enterprises RiverRenew Tunnel System: Hooffs Run Interceptor Planting Plan and provided comments and best practices.
- On February 21, 2022, staff met onsite at Mount Jefferson Park with a large group of neighboring residents and discussed non-native invasive plant removal work at the park and plans for park improvements.

4. JEROME “BUDDIE” FORD NATURE CENTER

a. Programs/Updates:

- The Nature Center re-opened to the public Thursday-Saturday from 10am to 4pm. During the month, there were 7 interpretive programs attended by 75 participants. The combined total number of visitors and participants for February was 416 people.

School Programs:

- William Ramsay ES – Pre-k classes from William Ramsay Elementary School visited the center to learn about hibernation. They were able to meet several animals from our collection including the American toad, corn snake, and box turtle.

Outreach Programs:

- Scout Program – February 14 – Nature Center staff led a World Thinking Day program for the Girl Scout Daisy Troop from MacArthur Elementary. The girls learned about forest ecosystems and how we can do our part to care for trees.

Onsite Programs:

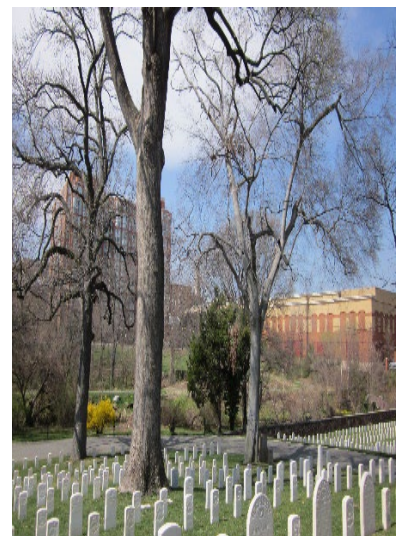

ITEM 5b.: BACKLICK GREENWAY DESIGN (VULCAN SITE)

ISSUE: Presentation of the proposed Backlick Greenway along Backlick Run within the Vulcan Materials site at 701 S Van Dorn Street.

RECOMMENDATION: That the Park and Recreation Commission review the proposed design for a future City park.

BACKGROUND: Lennar and Potomac Land Group II, LLC are designing a future 271,865 sq. ft. (6.24 acre) park, as part of a pending development case. If the overall project is approved, they will dedicate the park to the city as part of the redevelopment of the Vulcan Materials industrial site. In addition to the park, the proposal includes a neighborhood of townhomes, stacked townhomes, multifamily condominium buildings, and a hotel with retail (see Attachment 1).

The future public park, part of Backlick Greenway, is partially within the 100-year floodplain and is almost entirely within the Resource Protection Area (RPA) associated with Backlick Run. Accordingly, the applicant team has a proposed a design that restores and respects the RPA including a context sensitive planting mix and features such as an exercise path, picnic tables and benches, natural play areas, and interpretive signs. One major feature will be an overlook with steps down to the water.

In addition to Backlick Greenway, the applicant will maintain three publicly accessible, private open spaces: a pair of north-south pedestrian green streets that connect the multifamily condominium buildings through the townhouse community to the park and a playground located outside of the RPA in the southwest corner of the site adjacent to the park. Visitors could access the greenway and other open spaces walking from bus stops on N Van Dorn Street, including the future West End Transitway, and via adjacent on-street parking.

DISCUSSION: The Eisenhower West Small Area Plan (SAP) chapter of the Alexandria Master Plan envisioned restoring the banks of Backlick Run to create Backlick Run Greenway (see Figure 1). Constructing this park would advance the greenway and the design responds to the recommendations of the SAP, including:

- Restoring and stabilizing the stream, removing invasive species, and removing impervious surfaces,
- Providing a multiuse trail and passive open space, including benches and picnic areas,
- Making the stream edge accessible, and
- Interpreting the environmental role of the stream and park design with signage.

Staff supports the general design of the park with one significant addition. We recommend including a bridge spanning Backlick Run for pedestrians, cyclists, and emergency responders. This bridge would connect both sides of Backlick Run and provide a more hospitable route for pedestrians, cyclists, and bus riders to access the park. In addition, the bridge would further a principle of the SAP to link and expand the pedestrian, bicycle, and trail system in Eisenhower West. With this change, we believe that the park design would satisfy the SAP and provide an important open space for residents of the immediate neighborhood and wider Eisenhower West community. Staff recommends close coordination with the design team during the Final Site Plan process and construction to ensure that all elements are designed and implemented to ensure the long-term success of the park and restoration of the RPA.

The applicant has submitted their Concept Plan and anticipate receiving project approvals at the Planning Commission and City Council public hearings next fall. The applicant will be working with RP&CA on additional community engagement this spring. Engagement efforts will be tailored to the West End Van Dorn/Landmark area, and will include HOA's, civic associations, and the Ad Hoc Eisenhower West/Landmark Van Dorn Implementation Advisory Group. A Park and Recreation Public Hearing will also be scheduled prior to the fall.

FISCAL IMPACT: The applicant team will fund, design, and construct the park improvements. RP&CA will be responsible for maintaining the park. Annual maintenance costs will be identified through the planning process described above.

SUBJECT: 2022 LAND & WATER CONSERVATION FUND FOR FUNDING PARK
IMPROVEMENTS AT JOHN EWALD PARK

ISSUE: On Tuesday, March 8, 2022, City Council authorized the City Manager to execute all necessary documents for the Department of Recreation, Parks & Cultural Activities (RPCA) to submit the necessary documents for the Land & Water Conservation Fund (LWCF) matching grant.

BACKGROUND: The National Parks Service (NPS) administers a grant-in-aid program for the acquisition and/or development of public outdoor recreation areas and facilities. Local jurisdictions may apply for 50% matching fund assistance from the Land & Water Conservation Fund (LWCF). These funds are provided from a federal apportionment from the NPS through the Virginia Department of Conservation and Recreation (DCR). Sites that received LWCF funding must be open, operated, and maintained in perpetuity as public outdoor recreation areas and the entire site may not be converted to other uses without prior approval by the NPS. The program is a matching, reimbursement program, meaning that the City must provide a match and be capable of financing the project in its entirety while requesting periodic reimbursement.

DISCUSSION: In 2016, RPCA completed a multi-year process to develop a series of Neighborhood Park Improvement Plans, including John Ewald Park. Six of the recommendations in the John Ewald Park Plan are recommended for the LWCF:

1. Recommendation 3: Install a second basketball court;
2. Recommendation 4: Renovate the natural turf field and add a walking path;
3. Recommendation 5: Replace the old pool site with multi-use courts;
4. Recommendation 6: Restore the existing playground to forest area;
5. Recommendation 8: Relocate the playground; and
6. Recommendation 9: Install shade structure and picnic area.

The plan recommends replacing the former pool area with sport courts to meet the increasing demand in the city. One of the courts will be a multi-use court and include a movable net for tennis and pickleball. The other court would be used for futsal.

The current playground is hidden from the street and difficult to access. Moving the playground to the former tennis court area will increase its visibility from Duke Street and encourage greater use. It

will also include new and modern equipment, shade structure and picnic facilities, and incorporate a multi-generational Parkour Course.

The existing basketball court is one of the most popular courts in Alexandria. Adding a second court will improve community access and community health.

The plan calls for the well-used turf area to be renovated with improved natural turf conditions, irrigation, and a walking path encircling the field.

If awarded, the LWCF would require a 50% match towards the project. The approved FY 2022 capital budget already includes \$240,000 for the design for the John Ewald Park Renovation. The proposed FY 2023 to FY 2032 capital budget includes construction funding for the playground renovation within the Playground Renovations CFMP for \$833,000 in FY 2023 which would meet the required match. The City would use the LWCF grant towards the implementation of Recommendations 3, 4, and 5 to add two multi-purpose courts, one basketball court, and improve the natural turf field in the park.

Submission is coordinated through the Virginia Department of Conservation and Recreation (DCR). Notification to grant awardees is anticipated in Fall 2022.

Staff recommends submitting the John Ewald Park project for this grant because it is part of the Neighborhood Parks Improvement Plan recommendations (Attached), which included extensive public engagement, and a 50% match is already planned in the City's budget. Staff considered other sites but did not find that they were suitably "shovel ready" or budgeted yet. The project is considered a priority project in the plan and addresses community needs in a west end park.

Per the grant requirements, an award to the City would require the 3.88-acre parcel of land to be protected in perpetuity for the purpose of outdoor recreation. Protecting this land is vital to ensuring future recreational opportunities in the West End. Other nearby parkland protected through federal programs include Ben Brenman Park and Armistead L. Boothe Parks, which were transferred to the City in 1997 through the Federal Lands to Parks program. In addition, Chinquapin Park, Angel Park and Forest Park were acquired through LWCF funding in the 1970s.

FISCAL IMPACT: \$1,073,000 City funding. LWCF requires a 50% minimum match. The total estimated construction cost for the John Ewald Park Renovation Project is \$2,000,000, of which \$1,073,000 will be a match from the Playground Renovations CFMP and the Park Renovations CFMP.

Improvement Recommendations

- 1 Create a turnaround and landscaped median in the parking lot**
The current parking lot is, unstriped and does not allow for turnaround space or landscaped medians. This plan proposes installing a landscaped median and trees to provide a turnaround. It would also include parking spaces for disabled park users. The lot would be designed to not impact healthy existing trees.
- 2 Create pedestrian entrance near Duke St./Jordan intersection**
A new formalized entrance to the park would create a small space for a park sign, benches, and bike racks. It would also provide park access close to the Duke Street and S. Jordan intersection, encouraging safer pedestrian access.
- 3 Install a second basketball court and maintenance path**
The existing basketball court is one of the most popular in the City. The addition of lights will require a special use permit and may be added at a later stage of implementation due to cost.
- 4 Renovate the turf and install a walking path**
The park holds one of the largest and most popular unfenced turf areas in the City. This plan proposes adding irrigation and re-turfing the field to better sustain the active use. Steps from the multi-use courts to the open turf area may also serve as spectator seating. A path around the field will create a location for running and walking. Walking the path seven times would equal a mile. As requested by the Park and Recreation Commission on October 17, 2015, staff will investigate the use of synthetic turf and lights prior to implementation.
- 5 Replace the pool and poolhouse with two multi-use courts**
The pool has been closed since 2011. When it was open there was low use as the site is not conducive to a high capacity aquatics facility. The current poolhouse blocks visibility from Duke Street creating an unsafe setting behind it. This plan recommends replacing the pool and poolhouse with sport courts to meet the increasing demand in the city. One of the courts will be a multi-use court and include a movable net for tennis and pickleball. The other court would be used for futsal (court soccer).

- 6 Restore the existing playground to forest area**
This area is hidden from the street and difficult to access. Planting new trees in this site will help increase the tree canopy in the City, per the Urban Forestry Master Plan.
- 7 Work with Alexandria Police Department (APD) to improve park safety, particularly in areas not visible from Duke St.**
This plan recommends on-going community group involvement and cooperation to keep "eyes on the park." This can occur through regularly scheduled events in the park, communication with APD and increased park use. Over time, these strategies and crime reports will be measured to ensure safety and determine if other Crime Prevention Through Environmental Design tactics should be pursued while not impacting healthy existing trees.
- 8 Move the playground to the former tennis court area**
Moving the playground to the former tennis court area will increase its visibility from Duke St and encourage greater use. It will also include new and modern equipment and may integrate water features.
- 9 Install shade structure and picnic area**
A shaded area with seating will provide a community gathering space. The shade structures will be integrated within the existing trees to provide year round shade.
- 10 Reserve space for community building**
A community building can provide space for civic meetings, restrooms, and recreation offices. The location of the building allows for sightlines throughout the park to increase surveillance. It is also located next to the picnic area to allow for joint uses.

SUBJECT: ATHLETIC FIELD LIGHTING PROPOSAL

ISSUE: Implementation planning to mitigate program displacement resulting from the closure of the Alexandria City High School Minnie Howard lighted synthetic turf rectangular field and increase program capacity to meet athletic field demand use.

RECOMMENDATION: The Department of Recreation, Parks and Cultural Activities (RPCA) will seek Special Use Permit (SUP) approval for the installation of athletic field lighting at four (4) athletic fields: Francis Hammond Middle School; Jefferson Houston K-8 School; Patrick Henry K-8 School & Recreation Center; and George Washington Middle School. Athletic field lighting combined with synthetic provides for up to approximately 1,100 additional hours of use per field annually.

BACKGROUND: Alexandria City Public Schools (ACPS) will begin construction on a replacement Alexandria City High School Minnie Howard campus school building. Construction will begin in April 2022 on the existing athletic facilities resulting in the displacement of approximately 1,383 hours of athletic programming, with a little more than half of the programming in direct support of ACPS athletic programs. The new school building will open in August 2024 for the start of the 2024-2025 academic year. Following the opening of the new school building, ACPS plans to demolish the old school building and rebuild the synthetic turf rectangular field and other sport amenities on the west side of the property. The new facilities are anticipated to open by fall 2025. In addition to the closure of the Alexandria City High School Minnie Howard campus, the chart on page 3 identifies more than 10 athletic complexes that will be offline from two months for up to three years for life cycle maintenance, ACPS modernization projects, and RPCA park renovation projects.

DISCUSSION: In response to the displacement of athletic programming, Department of Recreation, Parks and Cultural Activities (RPCA) staff have been in discussions with ACPS to determine options to mitigate the loss of the Alexandria City High School Minnie Howard lighted synthetic turf rectangular field. Short-term mitigation strategies currently being implemented include the distribution of displaced Minnie Howard campus activities to (1) existing rectangular and diamond fields; (2) direct community programming at the ACPS Parker-

Gray Stadium (without lighting); and (3) direct community programming at the ACPS practice field (Chinquapin Park) following planned turf enhancements.

Long-term mitigation and increased capacity recommendations include the installation of athletic field lighting at Francis Hammond Middle School; Jefferson Houston K-8 School; Patrick Henry K-8 School & Recreation Center; and George Washington Middle School. In addition, RPCA and ACPS are coordinating the installation of necessary infrastructure to support the installation of athletic field lighting at the Patrick Henry K-8 School & Recreation Center synthetic turf rectangular field (completion summer 2024) and George Washington Middle School synthetic turf rectangular field renovation (completion fall 2022).

RPCA in coordination with ACPS, proposes the following Community Engagement Plan for the approval of athletic field lighting:

- March 24 – Briefing presentation to Alexandria School Board Members
- April 11 – Presentation to Park & Recreation Commission Youth Sports Advisory Board
- Week of April 18 – Community Meeting #1 (Virtual)
- Week of April 25 – Community site visit at ACHS Parker-Gray Stadium
- Week of May 2 – Community Meeting #2 (Virtual)
- Week of May 9 – Community Site Visits at proposed locations
- May 19 – Park & Recreation Commission Public Hearing
- June 23 – Planning Commission Public Hearing (four (4) proposed athletic fields)
- July 7 – City Council Public Hearing (four (4) proposed athletic fields)

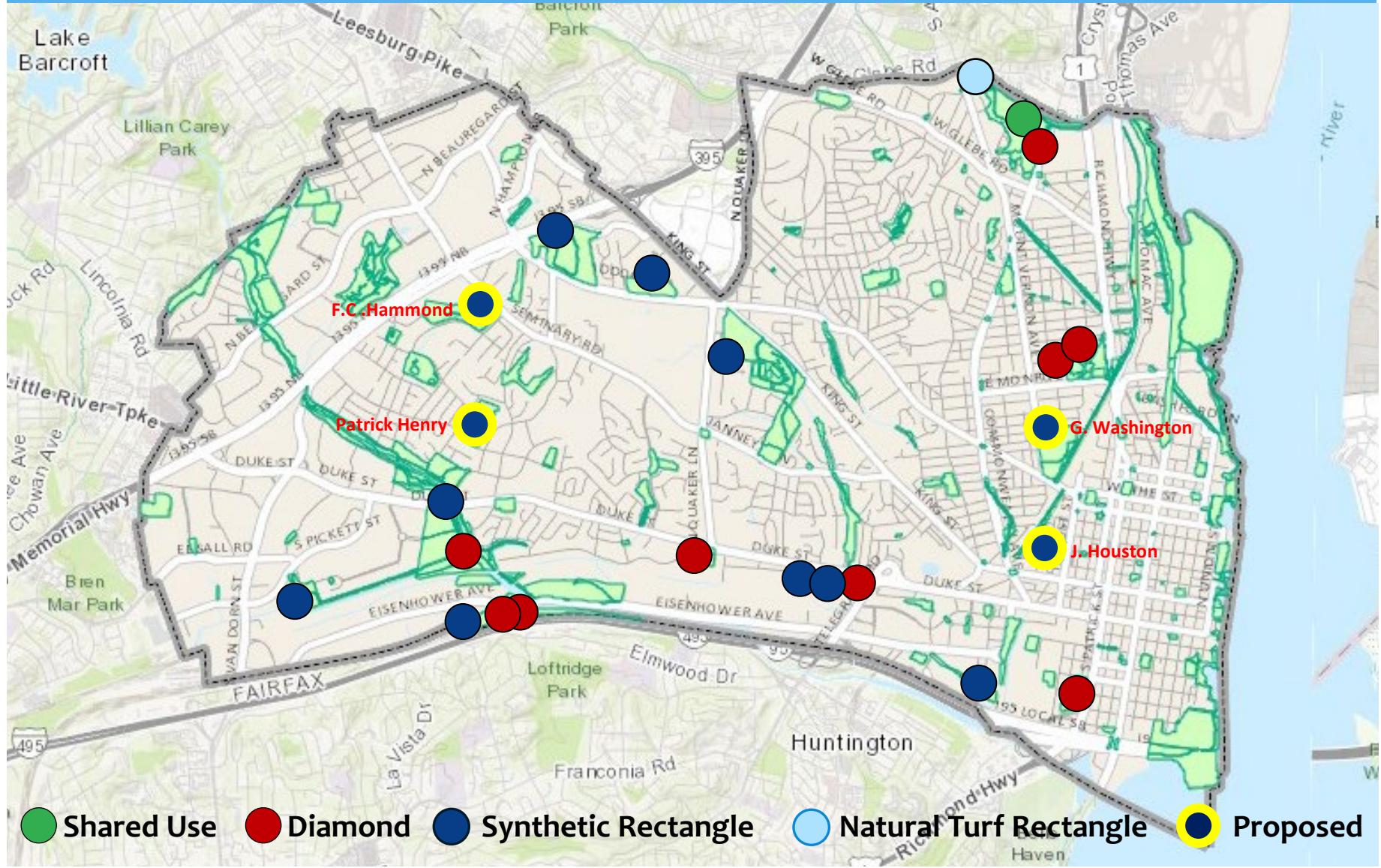
FISCAL IMPACT: \$804,000. Lighting of two synthetic turf rectangular fields in FY 2023 pending FY 2023 budget and SUP approvals.
