

2024-25 Power-On School Year Program Pre-Registration Eligibility Form



In alignment with the City of Alexandria's Social Equity Initiative, pre-registration in the 2024-25 Power-On School Year Program is available for families who qualify for federal assistance programs (free/reduced school meals, SNAP, and TANF). RPCA is offering the OSTP School Year Program for youth entering K - 6th grade in Fall 2024. Pre-registration opens June 9 and ends June 14. Families will be notified of their eligibility via email or by phone beginning June 19. General online only registration begins June 26 at 9am (online only). In-person and online registration begins June 27, until all openings are filled. Pre-registration forms can be completed online or completed on-site at one of the neighborhood recreation centers or any OSTP afterschool location during regular program hours.
