

Terms and Conditions of Global Dining Credit for Platinum Cardmembers

- These Benefit terms (including the benefit description above) set out the key terms of our Global Dining Credit for Platinum Cardmembers, which includes the Local Dining Credit and the Abroad Dining Credit.
- Enrolled Cardmembers will be eligible to receive a maximum of THB 7,000 back on spend at participating local restaurants (Local Dining Credit) and a maximum of THB 7,000 back on spend at participating abroad restaurants (Abroad Dining Credit) per redemption period. Spend can be in one or more transactions.
- The Local Dining Credit and Abroad Dining Credit cannot be combined, transferred or used in conjunction with each other.
- This benefit applies to spend on the primary Card enrolled into the offer, as well as any supplementary cards registered to the same primary Card.

- Only one enrolment is required for the Local Dining Credit and the Abroad Dining Credit from 1 February 2023 and Cardmembers will automatically be enrolled for the following redemption periods from their enrolment date and do not need to re-enrol.
- Benefit resets annually on 1 January until 31 December 2024.
- The dining credit benefit end date is subject to change and may end before the stated date. If this happens, we will notify you of the change and inform you of the new end date of the dining credit benefit.
- Credit not redeemed during the applicable redemption period will not roll over to the following redemption period and will expire. Your Card must be charged prior to the end of each redemption period (31 Dec) to be eligible for the credit within that redemption period.
- For the Abroad Dining Credit, valid transactions will be converted to Thai Baht based on the rate of exchange at the time your Card is charged. A currency conversion fee of 3% applies when payment is charged in a currency other than Thai Baht. This fee does not count toward the offer spend requirement.
- This Benefit is available to Primary American Express Platinum Cardmembers only. If you switch to a new Card product that is not eligible for this benefit, enrolment will be removed from your Card Account. If a Card you hold is ineligible, you will not be able to see the benefit, nor will you be able to save the benefit to the Card. If you are no longer eligible for this benefit due to a change in Account status, including but not limited to fraudulent flags, suspension, or cancellation, it will be removed from your Account.
- Benefit is only available for dine in services. Benefit excludes purchases of gift cards and vouchers, transactions made towards deposits charged upfront by the venue, cancellation and no-show charges, take away or dine-at-home services. Excludes transactions made through a third-party establishment or payment processor.

- Credit is not redeemable for cash or other payment form.
- Credit should appear on your billing statement within 5 business days from qualifying spend but may take up to 150 days from the offer end date.
- Credit may be reversed if: (i) your qualifying purchase is refunded or cancelled; and (ii) the Cardmember has received the awarded credit and subsequently cancelled their Cardmembership during the same Cardmembership year and already received a prorated annual fee refund.
- American Express reserves the right to reverse the awarded credit and enforce ineligibility from future benefits and other promotions for any misuse, fraud or gaming, as reasonably determined by American Express, related to your usage of this benefit which may result in any loss or damage to American Express. We will try to give you reasonable notice of any such incident and take reasonable steps to ensure you are not unfairly impacted if the incident is due to something we have done or failed to do. American Express reserves the right, at its sole discretion, to disqualify an individual from this benefit or future benefits and promotions if they are suspected of fraud, gaming or are in breach of any of the benefit's Terms and Conditions. - Any reversal of the awarded credit under this benefit's Terms and Conditions may take place up to a maximum of 180 days after the credit has been awarded. Please note that if an awarded credit is reversed after you have paid your bill, you may be returned to a negative balance.
- For restaurants in Japan, reservations and payments must be made via the Pocket Concierge website only in order to be eligible to receive credits.
- American Express is not liable for any of the food, beverages, products or services provided or received in connection with this benefit. In the event of loss, dissatisfaction or any dispute in relation to the products or services received under this benefit, please contact the restaurant directly.
