A BILL FOR AN ACT ENTITLED: "AN ACT PROHIBITING THE USE OF POLYSTYRENE FOAM CONTAINERS; CREATING CHAPTER 23 UNDER TITLE 25 A.S.C.A."

Preamble:

WHEREAS, over the years, American Samoa has experienced a dramatic increase in the importation of polystyrene foam containers (sometimes referred to as Styrofoam™); and

WHEREAS, polystyrene foam is used to make plates, cups, bowls, trays, and clamshell containers, all commonly used as food and beverage containers in American Samoa; and

WHEREAS, due to the physical properties of polystyrene foam, the U.S. Environmental Protection Agency finds "such materials can have serious impacts upon human health, wildlife, and aquatic environment, and the economy;" and

WHEREAS, polystyrene contains a chemical used in the production process called "styrene" that has been linked to cancer, as well as reproductive and developmental disorders, by the National Research Council; styrene leaches from polystyrene foam containers into food and drink, according to the Styrene Information Research Center, whose membership consists of approximately 95% of the North American styrene industry; and

WHEREAS, polystyrene also contains the chemical "benzene" which, according to the International Agency for Research on Cancer, is a well-established cause of cancer in humans; and

WHEREAS, the American Samoa Community Cancer Coalition states that cancer is the second leading cause of death in the Territory; and

WHEREAS, the general public typically is not warned or aware of any potential hazard from styrene and benzene that may leach from polystyrene foam containers into food and drink when heated; and

WHEREAS, polystyrene foam is a notorious pollutant of the marine environment (marine debris) that breaks down into smaller, non-biodegradable pieces that are often mistaken for food and ingested by seabirds and other marine life; and

WHEREAS, a January 2016 report by the World Economic Forum (WEF) finds an increasing rate of plastics entering the oceans and predicts that, without significant action to reduce the flow, by 2050, there will be more plastic (by weight) in the world's oceans than fish; according to the WEF report, most of these plastics come from packaging, including food and beverage containers, and much of these plastics are made from polystyrene foam; and

WHEREAS, a May 2017 report by the New York City Department of Sanitation determined that dirty, post-consumer, single-service polystyrene foam food and beverage containers cannot be recycled in a manner that is economically feasible or environmentally effective; and

WHEREAS, due to these concerns, more than 100 jurisdictions in the United States have banned or restricted the sale or use of polystyrene foam containers and packaging materials, and several local businesses and a number of U.S. corporations have successfully replaced polystyrene foam containers with alternative, cost-competitive products; and

WHEREAS, due to American Samoa's own unique challenges, such as limited resources and geographic isolation, the continued widespread use of polystyrene foam containers will have a detrimental effect on public health, the land and marine environment, and territorial waste management efforts; and

WHEREAS, it is in the public's interest for the Legislature to adopt this restriction on polystyrene foam containers, in order to protect the health, natural environment and resources of the people of American Samoa.

BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:

Section 1. There is created a Chapter 23 under Title 25 A.S.C.A. which reads:

"CHAPTER 23
POLYSTYRENE FOAM CONTAINER BAN

25.2301 This Act.

This Act shall be known as the "Polystyrene Foam Container Ban."

25.2302 Definitions.

(a) For purposes of this Act, the following definitions shall apply:

(1) "Acceptable alternative to polystyrene foam containers" means any food service container that meets the ASTM Standard Specification D6400 or D6868, is certified as a compostable product by the Biodegradable Products Institute (BPI), or is composed of paper or other plant fiber.

(2) "ASTM Standard Specification" means the Standard Specification for Compostable Plastics D6400 or the Standard Specification for Biodegradable Plastics D6868, as adopted or subsequently amended by the American Society for Testing and Materials (ASTM) also known as ASTM International.

(3) "Polystyrene foam" means blown polystyrene and expanded and extruded foams that are thermoplastic petrochemical materials utilizing a styrene monomer.

(4) "Polystyrene foam container" means a food service container that is composed, in whole or in part, of polystyrene foam. This includes, but is not limited to, plates, cups, bowls, trays and hinged or lidded containers, also known as clamshells.

25.2303 Prohibition on polystyrene foam containers.

(a) No person shall import, sell, offer for sale, or otherwise distribute polystyrene foam containers in the Territory of American Samoa, unless exempted under this Act.

(b) Any shipment of prohibited polystyrene foam containers arriving in American Samoa after the effective date of this Act shall be held at the port of entry. The importer shall be responsible for shipping the prohibited polystyrene foam containers out of American Samoa within sixty (60) days of the arrival date and for

the payment of all associated port costs and fees. Any prohibited polystyrene foam product imported for commercial sale prior to the effective date of this act shall be sold within six (6) months of the effective date. All unsold products shall be subject to confiscation and the cost of its disposal shall be paid by the importer or shipper.

(c) If product composition cannot be readily verified by local government officials, it is the importer's responsibility to provide documentation from the product manufacturer or supplier to verify compliance with this Act. If product testing is required for verification of composition, it will be performed at the importer's expense.

25.2304 Enforcement powers.

(a) This Act shall be enforced by issuance of a written citation.

(1) The form of the citation shall be approved by the Attorney General, and copies of the form shall be ordered and paid for by each agency having authority to issue citations under this Act.

(2) Citations shall be signed by the person who issues the citation.

(3) A citation must be served by personal delivery to the defendant.

(4) No code sections need be specified if the charged violation specifically designated through the use of indicated boxes provided on the citation.

(5) The citation may also contain other information pertinent to the offense charged, together with such forms for appearance, plea, and waiver as may be necessary.

(b) Answering and contesting citations shall follow the procedures set forth in Title 25 Chapter 20 of the American Samoa Code Annotated.

(c) A sanitarian or other authorized person, including members of the Department of Public Safety, authorized employees of the solid waste agency, or authorized employees of ASEPA, the Department of Health, or the Department of Marine and Wildlife Resources may issue citations for violations of this Act, provided that any person so authorized has the training and experience necessary to perform the job as determined in consultation with the Attorney General.

(d) In addition to other enforcement provisions and penalties in this Act, where there is reasonable cause to believe that a violation of this Act, or rule adopted pursuant to it, has occurred, or is occurring, authorized employees of ASEPA may issue a stop order to the person or establishment responsible for the violation. The stop order must detail the facts alleged to constitute a violation and may include an order that necessary corrective action be taken within a reasonable time and must be served on the person in violation of this Act. Further, authorized employees of ASEPA may seize any supply or inventory of polystyrene foam containers in conjunction with issuance and service of a stop order. In the event of the failure of the person to comply with the order, the Director of ASEPA, after consultation with the Attorney General, may apply to the High Court for injunctive relief and, in the event a seizure has occurred, shall include a claim for forfeiture of the seized polystyrene foam containers.

25.2305 Penalties

(a) Violation of any provision of this Act is an infraction punishable under the following schedule of fines, at the discretion of the District Court, unless otherwise specifically provided:

(b) Any fine imposed under this Act must be paid to the violations bureau within the time specified by the court. If the court does not specify a deadline, payment must be made no later than fourteen (14) calendar days from the date the fine is imposed.

(c) All fines collected shall be deposited into the general fund and subject to appropriation by the Legislature and approval by the Governor.

25.2306 Enforcement costs.

(a) In addition to any fines or other costs assessed under this Act, the court shall impose a polystyrene enforcement fee of ten dollars (\$10.00) per conviction under this Act.

(b) Such fee, when assessed, shall be segregated into a separate account designated "ASG -Polystyrene Enforcement Account" overseen by the Treasurer of American Samoa. Such funds shall be expended solely for government-led enforcement efforts related to this Act including, but not limited to, inspector training, polystyrene materials testing, and the purchase and maintenance of necessary materials and equipment. ASEPA is the government agency designated to administer these funds.

(c) The revenues generated from the fee imposed in this section shall be subject to appropriation by the Legislature and approval by the Governor.

25.2307 Administrative management.

(a) ASEPA is designated as the agency responsible for implementation and administration of this Act, to include coordinating public education programs and enforcement efforts.

(b) Notwithstanding the effective date of this Act, ASEPA is authorized to immediately undertake, pursuant to the Administrative Procedures Act, A.S.C.A. 4.1001 et seq., promulgation of regulations necessary to implement and enforce the provisions of this Act.

25.2308 Polystyrene product exemptions.

(a) Automatic exemptions. The following polystyrene foam containers are exempt from the provisions of this Act:

(1) imported prepackaged food;

- (2) trays used for raw meat, poultry, fish, or frozen foods;
- (3) polystyrene foam coolers and ice chests intended for reuse;
- (4) packaging materials for non-food items.

(b) Special requests for an exemption. Any person may seek an exemption from the provisions of this Act upon demonstrating that strict application of the requirements would cause undue hardship. "Undue hardship" shall be construed to include, but not be limited to: (1) situations where there are no acceptable alternatives to packaging with polystyrene foam containers for reasons that are unique to the applicant; or (2) situations where compliance with this Act would deprive a person of a legally protected right.

(c) Application process for exemption: (1) the person seeking an exemption shall submit a completed exemption application to ASEPA; (2) the exemption application shall include all information and documentation necessary for ASEPA to make a finding that imposition of this Act would cause an undue hardship; (3) ASEPA may require the applicant to provide additional information in order to make a determination regarding the exemption application; (4) ASEPA may grant an exemption for a period of up to one year; (5) in order to have any exemption extended, the applicant must re-apply for the exemption sixty days prior to the expiration of the existing exemption period and demonstrate continued undue hardship; (6) extensions may be granted for intervals not to exceed one year.

25.2309 Temporary excise tax reduction.

(a) In order to aid in the Territory's transition from polystyrene foam containers to acceptable alternatives, a one-year temporary excise tax reduction will be implemented as follows:

(1) For a period of one year, beginning on the Act's passage date and ending the day before the Act's effective date, acceptable alternatives to polystyrene foam containers, imported for commercial use and resale purposes, will be eligible for a temporary reduction of the excise tax required under Section 11.1002(a)(7), resulting in a reduction from eight percent (8%) to four percent (4%) of the basis of all such items.

(2) The American Samoa Government, Department of Treasury, Customs Division, will be responsible for assessing and collecting the temporary excise tax provided for in this Act.

(3) ASEPA will be responsible for generating, and periodically updating, an official listing of acceptable alternatives to polystyrene foam containers which qualify for the temporary excise tax reduction provided for in this Act.

25.2310 Preservation of authority

The provisions of this Act shall not in any way preempt or diminish the authority of any government agency to enforce other laws or regulations in the Territory, including those relating to Environmental Health in this Title, such as food and beverage sanitation, (Chapter 6) or solid and industrial waste (Chapter 20).

25.2311 Severability.


If any provision of this Act or its application to particular persons or circumstances is held invalid by a court of law, the application of such provision to other persons or circumstances shall not be affected, nor shall the remainder of the provisions of this Act be affected thereby."

Sec 2. Effective Date.

This bill shall become effective 60 days after the end of the session at which it has been passed.
