The staff of the Air Resources Board (ARB) invites you to a public meeting on April 5, 2001 to discuss the ARB's regulatory and non-regulatory fuel activities for 2001. This will be the second meeting for this year's fuels regulatory agenda and non-regulatory activities.

Items that will be discussed at the public meeting include:

- 1) development of amendments to the California diesel fuel regulations;
- 2) evaluation of diesel engine lubrication oils, diesel fuel additives and diesel fuel lubrication properties;
- 3) development of California Phase 3 Reformulated Gasoline (CaRFG3) vehicle certification fuel standards;
- 4) review of de minimus levels for methyl tertiary butyl ether (MTBE) and other ethers in CaRFG3 regulations; and
- 5) ongoing work on the effects of ethanol in gasoline regarding commingling and permeation.
