Dear Sir or Madam:

The staff of the Air Resources Board (ARB) will hold a public workshop to discuss ARB's regulatory and non-regulatory fuel related activities. This workshop will be the sixth meeting to discuss this year's fuels regulatory and non-regulatory activities. In addition, staff will present two regulatory proposals tentatively scheduled for the Board's consideration at the November 18-19, 2004 public hearing.

Topics may include, but are not limited to, issues relating to the implementation of the California Phase 3 Reformulated Gasoline (CaRFG3) regulations, evaluation of potential future revisions to the California Reformulated Gasoline specifications, and consideration of specifications for bio-diesel. In addition, staff will present a regulatory proposal to extend the CARB diesel fuel regulations to intrastate locomotives and commercial harbor craft and technical changes to the CaRFG3 regulations. 
