ACDHH Recommendations for Consideration:

- I. House Ad Hoc Committee on Abuse and Neglect of Vulnerable Adults Committee Recommendations (December 17, 2019)
- 9) Acknowledge that caregivers are vital skilled professionals and that stability and consistency are essential for the wellbeing of our most vulnerable populations and that appropriate compensation, training and support must be addressed...

ACDHH follow up on recommendation #9: Include the ability to effectively provide services towards individuals who are Deaf, Hard of Hearing and DeafBlind particularly in regards to communication access and individuals who may have limited English skills.

- II. HHS Committee of Reference and Senate Health and Human Services Committee of Reference Final Recommendations (June 16, 2022)
- 5) DHS should provide data download to the Auditor General in the format that she prescribes, in fields that she prescribes, and containing the fields that she requests for all complaints...

ACDHH recommendation to build onto recommendation #5: Ensure fields include specifics regarding individuals who are Deaf, Hard of Hearing and DeafBlind, noting communication access.

III. Initial Auditor General's Report and Arizona DHS 30- Month Follow-up - Long-term Care Facility Complaints and Self-Reports (July 14, 2022)

No additional comments related to the auditor's report; reference to DHS presentation for initial five recommendations presented by the Auditor General.

IV. Department of Health Services Presentation to Abuse and Neglect of Vulnerable Adults Ad-Hoc Committee (July 14, 2022)

Recommendation A-

ACDHH recommendation: Surveyors should have knowledge of access to effective communication for residents who are Deaf, Hard of Hearing and DeafBlind in order to recognize communication deficiencies that may be present in complaints that are filed in order to assess abuse or neglect based on language deprivation.

All surveyors should be aware of the Department's obligation to provide equal access to effective communication and how to secure such services for residents who are Deaf, Hard of Hearing and DeafBlind when involved with investigations. Surveyors should be required to participate in an annual training provided by ACDHH.

Recommendation B-

ACDHH recommendation: Execute the complaint and investigation process in American Sign Language (ASL) for residents and family members whose primary language is ASL.

V. ACDHH further recommendations for consideration:

Recommendation: Provide further information and clarification on how DHS specifically meets CMS requirements in serving deaf, hard of hearing and deafblind individuals.

Recommendation: Define "nonverbal" or replace with more detailed description (e.g. Deaf, paralysis, autism, mental illness, dementia, aphasia, stroke, physical illness, etc.) and add emphasis if an individual is unable to communicate for themselves.

Recommendation: Ensure full representation of all populations served on agency task forces, e.g. ACDHH

Recommendation: to create an Independent Oversight Committee for DHS, which is overseen by the Arizona Department of Administration (ADOA) (who also oversees the DES and AHCCCS Independent Oversight Committees).

For instance:

"The DES Independent Oversight Committees, known as IOCs, are groups of local volunteers who provide independent oversight in matters regarding the human rights of members with developmental disabilities who are supported by the Arizona Department of Economic Security/Division of Developmental Disabilities. There is, at a minimum, one IOC committee for each of the 5 DDD Districts. The IOCs review Behavior Plans, Planning documents and Incident Reports. The IOCs also review any other potential human rights violations that are reported to the committee.

The AHCCCS Independent Oversight Committees on Behavioral Health are established in accordance with ARS § 41-3802 and 41-3804. The AHCCCS IOC committee by regions are currently serving: Central Arizona, Northern Arizona, and Southern Arizona. Each IOC may hold community forums. According to statute AHCCCS shall ensure that each Regional Behavioral Health Authority (RBHA) and its providers develop and implement human rights training plans ensuring that providers are properly certified or qualified (as appropriate)." House Ad Hoc Committee on Abuse and Neglect of Vulnerable Adults Committee Recommendations

AARP Arizona

- 1. Funds must be made available to investigate LTC Facilities
- 2. Increase the civil and criminal penalties for those facilities, owners, and staff that abuse, neglect, or exploit older adults
 - a. This includes closing loopholes that allow for owners to skirt punishment
- 3. Establish a threshold for which a thorough investigation is triggered that takes the facility and their practices into account rather than each incident on their own
 - a. To trigger these investigations there are a few factors to consider:
 - i. Size of the facility/number of residents
 - ii. The level of complaint (Imminent Threat or High Priority)
 - iii. The time between the above level of complaints
 - 1. For example, if a small group home (12 residents) were to receive 2 complaints at the "High" and "Imminent Threat" levels in under a year's time, that would qualify for a full investigation.
 - b. This means that the presenting problems are investigated, however a deeper investigation is required
 - c. There should be stiff penalties for those who "knowingly" levy false complaints against a facility, their staff, management, or ownership
 - d. If a claim is proven to be false and/or was withdrawn is expunged from the facility's record to not cause harm
- 4. Establish criteria for complaints initially filed at the level of "Imminent Threat" or "High Priority" to be downgraded to a lower priority status <u>only</u> when specific criterial are met; failure to do so will result in penalties
 - a. Given that Department officials moved items to a lower priority status, there must be a process in place downgrade the status of higher level complaints
- 5. Lastly, we believe that a focus should be placed on the first recommendation for a couple of reasons:
 - Arizona needs a centralized hub/repository for complaints against facilities in which these complaints are directed to the appropriate agency (Police, AG's office, Ombudsmen, NCIA Licensing Board, APS, ADHS, etc.)
 - b. Arizona also need a Single-Point of Entry (SPE) in order for Arizonans to efficiently access the services they need and that are available to them

HOUSE AD HOC COMMITTEE ON ABUSE AND NEGLECT OF VULNERABLE ADULTS FINAL RECOMMENDATIONS

Recommendation #1: The Speaker continues the House Ad Hoc Committee on Abuse and Neglect of Vulnerable Adults.

Recommendation #2: Improve and enhance methods of effective communication with all vulnerable adults to make sure that equitable communication will meet their needs.

Recommendation #3: Bring stakeholders together to design a single point of entry for complaints of abuse or neglect of vulnerable adults that will be effective for all Arizonans.
