**CHAPTER 130**  
**HOUSE BILL 2116**

AN ACT

AMENDING SECTION 36-3503, ARIZONA REVISED STATUTES; RELATING TO CHILD FATALITIES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 36-3503, Arizona Revised Statutes, is amended to  
3 read:

4 36-3503. Access to information; confidentiality; violation;  
5 classification

6 A. On request of the chairperson of ~~the~~ THE state or A local CHILD  
7 FATALITY REVIEW team and as necessary to carry out the team's duties, the  
8 chairperson shall be provided within five days excluding weekends and  
9 holidays with access to information and records regarding a child whose  
10 death is being reviewed by the team, or information and records regarding  
11 the child's family and records of a maternal fatality associated with  
12 pregnancy pursuant to section 36-3501, subsection C:

13 1. From a provider of medical, dental or mental health care.

14 2. From this state or a political subdivision of this state that  
15 might assist a team to review a child fatality.

16 B. A law enforcement agency with the approval of the prosecuting  
17 attorney may withhold FROM RELEASE PURSUANT TO SUBSECTION A OF THIS  
18 SECTION ANY investigative records that might interfere with a pending  
19 criminal investigation or prosecution.

20 C. The director of the department of health services or the  
21 director's designee may apply to the superior court for a subpoena as  
22 necessary to compel the production of books, records, documents and other  
23 evidence related to a child fatality or a maternal fatality associated  
24 with pregnancy investigation. Subpoenas issued shall be served and, on  
25 application to the court by the director or the director's designee,  
26 enforced in the manner provided by law for the service and enforcement of  
27 subpoenas. A law enforcement agency is not required to produce the  
28 information requested under the subpoena if the subpoenaed evidence  
29 relates to a pending criminal investigation or prosecution. All records  
30 shall be returned to the agency or organization on completion of the  
31 review. Written reports or records containing identifying information  
32 shall not be kept by the team.

33 D. All information and records acquired by the state team, ~~or~~ any  
34 local team OR A PROGRAM are confidential and are not subject to subpoena,  
35 discovery or introduction into evidence in any civil or criminal  
36 proceedings, except that information, documents and records otherwise  
37 available from other sources are not immune from subpoena, discovery or  
38 introduction into evidence through those sources solely because they were  
39 presented to or reviewed by a team OR PROGRAM.

40 E. Members of a team, persons attending a team meeting and persons  
41 who present information to a team may not be questioned in any civil or  
42 criminal proceedings regarding information presented in or opinions formed  
43 as a result of a meeting. This subsection does not prevent a person from  
44 testifying to information that is obtained independently of the team or  
45 that is public information.

1 F. PURSUANT TO POLICIES ADOPTED BY THE STATE CHILD FATALITY REVIEW  
2 TEAM OR A MATERNAL MORTALITY REVIEW PROGRAM, a member of the state or a  
3 local child fatality review team ~~shall not~~ OR A MATERNAL MORTALITY REVIEW  
4 PROGRAM, OR THE MEMBER'S DESIGNEE, MAY contact, interview or obtain  
5 information ~~by request or subpoena~~ from a CLOSE CONTACT OR FAMILY member  
6 of a ~~deceased child's family, except that a member of the state or a local~~  
7 ~~child fatality review team who is otherwise a public officer or employee~~  
8 ~~may contact, interview or obtain information from a family member, if~~  
9 ~~necessary, as part of the public officer's or employee's other official~~  
10 ~~duties~~ CHILD OR WOMAN WHO DIES WITHIN THE TEAM'S OR PROGRAM'S  
11 JURISDICTION. THE CHILD FATALITY REVIEW TEAM AND MATERNAL MORTALITY  
12 REVIEW PROGRAM SHALL ESTABLISH A PROCESS FOR APPROVING ANY CONTACT,  
13 INTERVIEW OR REQUEST BEFORE ANY TEAM OR PROGRAM MEMBER OR DESIGNEE  
14 CONTACTS, INTERVIEWS OR OBTAINS INFORMATION FROM THE CLOSE CONTACT OR  
15 FAMILY MEMBER OF A CHILD OR WOMAN WHO DIES WITHIN THE TEAM'S OR PROGRAM'S  
16 JURISDICTION. POLICIES ADOPTED PURSUANT TO THIS SUBSECTION MUST REQUIRE  
17 THAT ANY INDIVIDUAL WHO ENGAGES WITH A FAMILY MEMBER BE TRAINED IN TRAUMA  
18 INFORMED INTERVIEW TECHNIQUES AND EDUCATED ON SUPPORT SERVICES AVAILABLE  
19 TO THE CLOSE CONTACT OR FAMILY MEMBER.

20 G. State and local team AND PROGRAM meetings are closed to the  
21 public and are not subject to title 38, chapter 3, article 3.1 if the team  
22 OR PROGRAM is reviewing individual child fatality cases or cases of  
23 maternal fatalities associated with pregnancy. All other team AND PROGRAM  
24 meetings are open to the public.

25 H. A person who violates the confidentiality requirements of this  
26 section is guilty of a class 2 misdemeanor.
