Be it enacted by the Legislature of the State of Arizona: Section 1. Section 32-109, Arizona Revised Statutes, is amended to read:

## 32-109. <u>Technical registration fund</u>

- A. Pursuant to sections 35-146 and 35-147, the executive director shall deposit ten FIFTEEN percent of all fees or other revenues received by the board in the state general fund to assist in defraying the cost of maintaining the state government and shall deposit the remaining ninety EIGHTY-FIVE percent in a separate fund, known as the technical registration fund, to be used only in defraying expenses of the board and in prosecuting violations of this chapter.
- B. Monies deposited in the technical registration fund pursuant to subsection A of this section are subject to section 35-143.01.

- B. Monies deposited in the technical registration fund pursuant to subsection A of this section are subject to section 35-143.01.

## 32-505. Barbering and cosmetology fund

- A. The barbering and cosmetology fund is established.
