22 On the above captioned date and time, the court considered its Order to Show Cause Why
23 Sanctions Should Not Be Imposed Against Salman J. Borhani, State Bar No. 252739 For Failing
24 To Comply With General Order 06-03 and Local Bankruptcy Rule 5005-4 (“OSC”) dated
25 August 2, 2012. Appearances were stated on the record. Based upon findings of fact and
26 conclusions of law stated on the record pursuant to F.R.Civ.P. 52(a)(1), as incorporated into
27 FRBP 7052 and applied to contested matters by FRBP 9014(c), it is

28 ORDERED that Salman J. Borhani, State Bar No. 252739 (“Borhani”) is suspended from
practice before the United States Bankruptcy Court for the Central District of California pending
(1) the issuance to Borhani of a live ECF log-in and password in compliance with LBR 5005-4;

1 and (2) payment of the sum of \$ 500.00 in sanctions to the clerk of the court in compensation for
2 violation of LBR 5005-4 to the date of the OSC; and it is further

3 ORDERED that Borhani must file an ex parte application for reinstatement, supported by
4 a declaration establishing compliance with the terms of this order, to terminate this suspension
5 and to resume practicing before the United States Bankruptcy Court for the Central District of
6 California. A proposed order granting reinstatement must be lodged with the court upon the
7 filing of the application for reinstatement.
